Project 1 Facility Replacement


The Antelope Valley Project will require the 3200 Baldwin Avenue facility to be relocated in the future. Any expansion to the baseball/softball complex at Haymarket Park could require the relocation of our 901 North 6th Street facility including our snow dump facility. A facility study, completed in 1998, identified our 3180 South Street facility as to a possible need for relocation because of necessary response time to accommodate the growth area to both south and east of our city. This facility was also identified as in a residential setting with very limited growth potential. These resources are identified to give us the ability to select and purchase these relocated facility sites as needed with additional funding necessary for reconstruction of the facilities.

Project 2 Upgrade of Gasboy Card Control System

Upgrade of gas cards control to the existing Gas Boy fuel sites is needed for continued use to its customers. The old system is obsolete and in need of upgrading. Parts for this system are not available.
