Because of limited funds for transit enhancements, funding of projects for the Transit Study will be phased over a period until projects are completed.

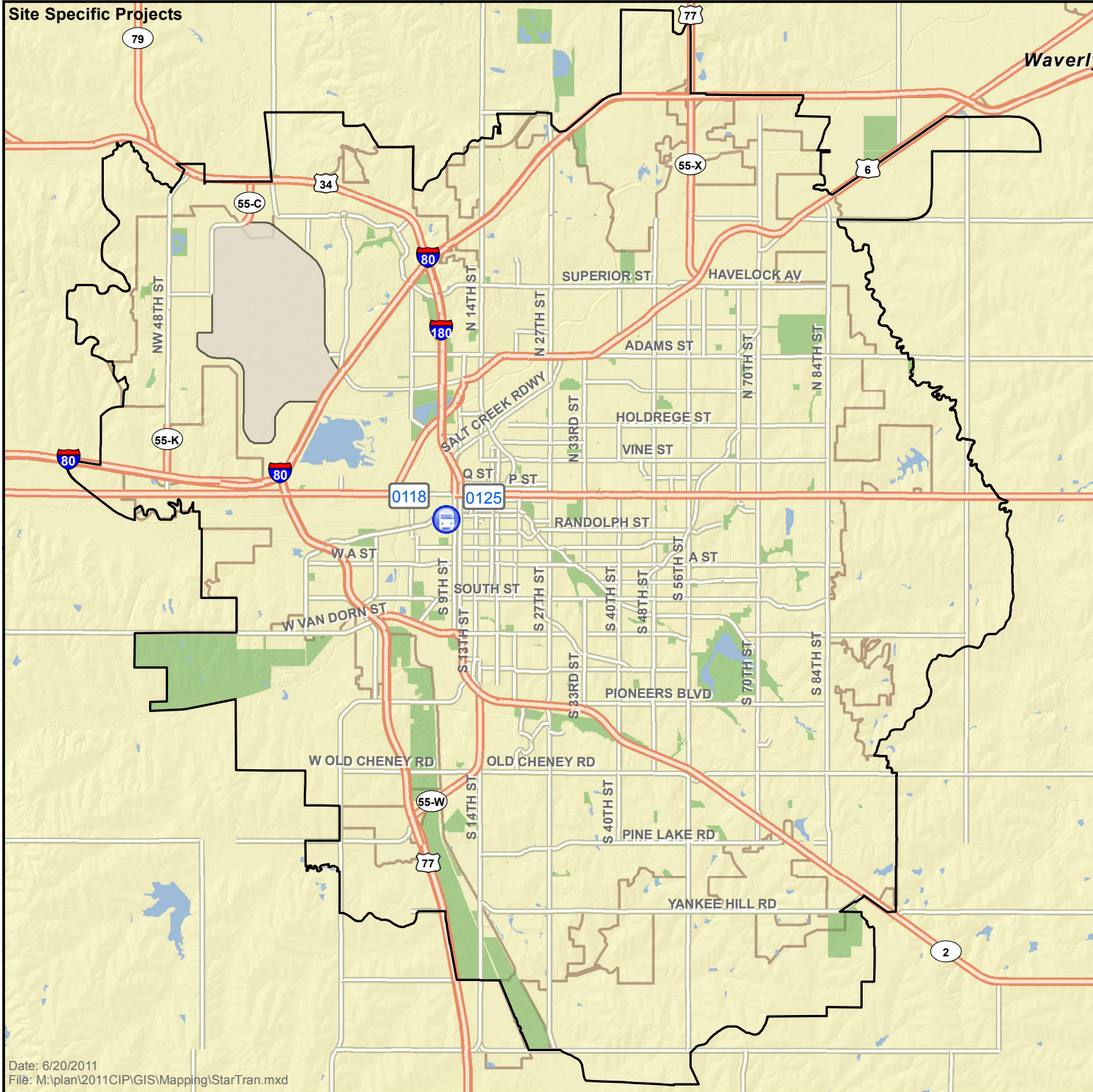

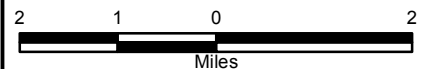
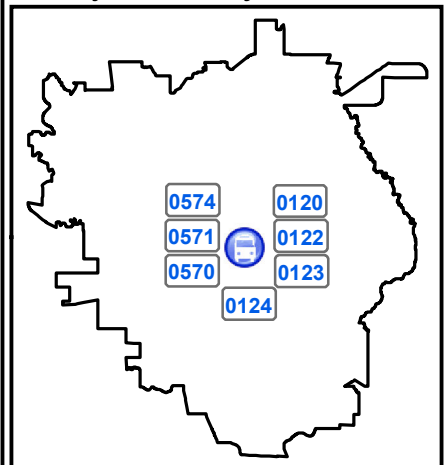


Project Locations
