

The Transportation improvement program (TIP) is a staged, multiyear, intermodal program of transportation projects to be undertaken by transportation agencies within the metropolitan planning area requesting federal funds. This document is consistent with the city, county and state capital improvement programs and is reviewed along with the Lincoln CIP for conformance with the Lincoln Lancaster County Comprehensive Plan.

According to the Lincoln Metropolitan Planning Organization (MPO) public participation process, the Technical Committee reviews the draft TIP and forwards the program to the Planning Commission for review and comment on the compliance of the program with the *Lincoln-Lancaster Comprehensive Plan* and *Long Range Transportation Plan*. After the public hearing, the Planning Commission forwards comments to the Officials Committee.

The following action was taken at the May 7, 2002 meeting of the Lincoln MPO Technical Committee:

Roger Figard proposed that the Technical Committee include the revisions identified by staff in the draft TIP and to make the language consistent between the City and the RTSD programs for those projects that the RTSD provides funding. A motion was made by Virendra Singh for the approval of the TIP as revised and for the TIP to be forwarded to the Planning Commission for public review and comment. The motion was passed in a unanimous vote.

MPO Technical Committee Changes to the draft Program

Agency: City of Lincoln *Division:* Public Works & Utilities: Streets and Highways

9. "O" Street (Hwy. 34) - 52nd Street to Wedgewood Drive, 66th Street - "O" Street to "Q" Street, Also 56th Street and Cotner Blvd. Between Randolph Street and "R" Street

Reconstruct the existing four lane "O" Street roadway to six through lanes, plus left turn and/or right turn lanes at intersections and also improve 66th Street to four through lanes plus left turn lanes. Operate 56th Street and Cotner Boulevard as a one-way pair between Randolph Street and "P" Street; "P" Street One-way west bound between 56th Street and Cotner Blvd. and "N" Street east bound between 56th Street and Cotner Blvd., including intersection design modifications and ITS applications. Federal-aid Project. Project length approx. 2.3 miles. (2002-04).

- Change NH funds to SF funding
- 31. Replace Harris Overpass between 3rd Street and 9th Street

This is a Railroad Crossing Overpass replacement project funded by RTSD. This project will replace the existing deficient overhead structure with a four (4) lane bridge divided roadway including a pedestrian facility. (2003-07).

- 32. Replace the "A" Street Salt Creek Bridge

This project will replace the existing deficient "A" Street & Salt Creek Bridge. The replacement structure will provide a two (2) lane bridge to include a pedestrian path on the north side and a bike path on the south side of the structure. (2003).
