DETAILS

Reason for Legislation

Hans Wanamaker has submitted an application for a sidewalk café in the public right of way on the sidewalk in front of The Cookie Company at 138 12th Street.

Discussion (Including Relationship to other Council Actions)

In 1996, Council approved amendments to the City Sidewalk Café Ordinance, LMC 14.50 to encourage and facilitate the development of sidewalk cafes in the business owned areas of the City. Since that time 9 new cafes have applied for use of public space 2 of which are no longer in operation. Several similar cafes have been developed on private property as well.

This application for a sidewalk café follows the applicant's unsuccessful attempt to meet specifications as a street cart. Because his device, the Grillwalker, has no wheels, he could not apply as a street cart under the City's existing regulations. The applicant imported the Grillwalker apparatus from Germany where it is used in various public venues, including street-based vending. In order to meet regulations for a sidewalk café, the applicant agrees to use only the designated space in front of the Cookie Company (owned by a family member) and to utilize the Cookie Company's facilities to store his product and wash his hands. This agreement was approved by the Health Department. Fire Prevention inspected the Grillwalker and found that it met with City regulations regarding fire safety.

The appropriate City Departments - Police, Fire Prevention, Health and Public Work - have reviewed this application and recommend approval as submitted.

The City's Urban Design Committee reviewed the request and recommended approval.
