

ORDINANCE NO. _____

1 AN ORDINANCE amending Section 19.03.100 of the Lincoln Municipal Code
 2 relating to the Lincoln Fire Code Permits and Permit Fees to require permits for the installation of
 3 fire alarms systems and establishing permit fees; and repealing Section 19.03.100 of the Lincoln
 4 Municipal Code as hitherto existing.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That Section 19.03.100 of the Lincoln Municipal Code be amended to read
 7 as follows:

8 **19.03.100 Section 105.6 Amended; Permits and Permit Fees.**

9 Section 105.6 of the International Fire Code is amended to read as follows:

10 **105.6 Permits and permit fees.**

11 **105.6.1 Permit required.** A permit shall be obtained from the bureau of fire prevention
 12 prior to engaging in the following activities, operations, practices, or functions and on items (3), (4),
 13 (6), (8), (9), (11) and (12), the premises shall be inspected annually and a permit must be obtained
 14 each year to continue the activities, operations, practices, or functions:

- 15 (1) Explosives and blasting agents, see Chapter 33.
- 16 (2) Fireworks, see Chapter 33 and L.M.C. Chapter 9.44.
- 17 (3) Flammable combustible liquids and tanks, see Chapters 22 and 34.
- 18 (4) Hazardous materials in excess of exempt amounts listed in Table 105.6.21.
- 19 (5) Storage and use liquified petroleum gas, see Chapter 38.
- 20 (6) Places of assembly.

- 1 (7) Pyrotechnic special effect material, see Chapter 33.
- 2 (8) Spraying or dipping operations utilizing flammable or combustible finishes, see
- 3 Chapter 15.
- 4 (9) Storage of scrap tires and tire byproducts that exceed 2,500 cubic feet, see Chapter
- 5 25.
- 6 (10) Temporary membrane structure, tent or canopy, see Chapter 24.
- 7 (11) Hotels and motels.
- 8 (12) Fraternities and sororities.
- 9 (13) Installation of fire alarm systems.

10 **105.6.2 Permit fees.** The following shall be the permit fees charged for the permits required
 11 in this section:

22 **105.6.3 Expiration.** Every permit for a fire alarm system issued by the bureau of fire
23 prevention shall under these provisions expire by limitation and become null and void if the work
24 authorized by such permit is not commenced within 120 days from the date of such permit, or if the
25 work authorized by such permit is suspended or abandoned at any time after the work has
26 commenced for a period of 180 days. Before such work can be recommenced, a new permit shall be
27 first obtained and the fee thereof shall be one-half the amount required for a new permit for such
28 work; provided that such suspension or abandonment has not exceeded one year. There shall be no
29 credits or refunds given on permits which have expired. Permit holders returning the unused permit
30 prior to the expiration date of the permit shall be limited to a maximum refund amounting to two-
31 thirds of the original fee if the original fee is \$75.00 or less. For permits where the original fee was

1 greater than \$75.00, a \$25.00 processing fee will be levied and the remaining fee amount will be
2 refunded to the permit holder.

3 **Sections ~~105.6.3~~ 105.6.4 through 105.6.46** are deleted.

4 Section 2. That Section 19.03.100 of the Lincoln Municipal Code as hitherto existing
5 be and the same is hereby repealed.

6 Section 3. That this ordinance shall take effect and be in force from and after its
7 passage and publication according to law.
