

RESOLUTION NO. A-_____

1 A resolution authorizing the filing of applications with the United States Department of
 2 Transportation for financial assistance during Fiscal Year 2006-2007 (September 1, 2006 - August
 3 31, 2007) under the Urban Mass Transportation Act of 1964, as amended.

RECITALS

I

The Secretary of Transportation is authorized to make grants for mass transportation projects.

II

8 A contract between the City of Lincoln and the United States Department of Transportation
 9 for financial assistance will impose certain obligations upon the City of Lincoln as an applicant for
 10 funding, including the provision by it of the local share of project costs.

III

12 It is required by the United States Department of Transportation, in accordance with the
 13 provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an
 14 application for assistance under the Urban Mass Transportation Act of 1964, as amended, the
 15 applicant gives an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and
 16 the United States Department of Transportation requirements thereunder.

IV

18 It is the goal of the City of Lincoln, Nebraska, as an applicant, that minority business
 19 enterprises be utilized to the fullest extent possible in connection with these projects, and that
 20 definitive procedures shall be established and administered to ensure that minority businesses shall

1 have the maximum feasible opportunity to compete for contracts when procuring construction
2 contracts, supplies, equipment contracts, or consultant and other services.

3 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lincoln,
4 Nebraska:

5 1. That the Mayor is authorized to execute and file applications on behalf of the City of
6 Lincoln with the United States Department of Transportation for financial assistance to aid in the
7 financing of planning and technical studies, research, or capital assistance projects, or both, pursuant
8 to Sections 3, 3(a) (1) (c), 4(1), 6, 8 and 9 of the Urban Mass Transportation Act of 1964, as
9 amended.

10 2. That the Mayor is authorized to execute and file with such applications an assurance or
11 any other document required by the United States Department of Transportation effectuating the
12 purposes of Title VI of the Civil Rights Act of 1964.

13 3. That the Mayor is authorized to set forth and execute affirmative minority business
14 policies in connection with the project's procurement needs.

15 4. That the City's Director of Public Works & Utilities is authorized to furnish such
16 additional information as the United States Department of Transportation may require in connection
17 with the application for the financial assistance.

18 5. That the Mayor is authorized to execute grant agreements, and amendments and
19 addendums thereto, on behalf of the City of Lincoln with the United States Department of
20 Transportation, and such other documents as may be necessary, for aid in the financing of the
21 planning and capital assistance program of projects.
