

ORDINANCE NO. _____

1 AN ORDINANCE amending Title 24 of the Lincoln Municipal Code, Plumbing and
 2 Sewers, by amending Section 24.38.070 to increase permit fees relating to on-site wastewater
 3 treatment systems; amending Section 24.42.110 to increase the fee for evaluation and review of
 4 Property Transfer Inspector reports and any necessary site visits by the Health Director; and
 5 repealing Sections 24.38.070 and 24.42.110 of the Lincoln Municipal Code as hitherto existing.

6 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

7 Section 1. That Section 24.38.070 of the Lincoln Municipal Code be amended to
 8 read as follows:

9 **24.38.070 Fees.**

10 The following fees for permits are required:

- 11 (a) On-site wastewater treatment system construction permit fee:
 - 12 Standard System ~~\$290.00~~ \$305.00
 - 13 Non-standard System ~~\$420.00~~ \$440.00
- 14 (b) On-site wastewater treatment system repair permit fee ~~\$160.00~~ \$170.00
- 15 (c) Non-standard on-site wastewater treatment system
 - 16 annual operating permit fee ~~\$ 45.00~~ \$50.00
- 17 (d) Cleaner’s permit fee (annual) ~~\$335.00~~ \$350.00
 - 18 This permit is issued on an annual basis, expires on
 - 19 May 31 of each year, and is renewable on payment of
 - 20 the annual fee and demonstrated compliance with the
 - 21 requirements of this chapter.
- 22 (e) Any person who secures a registration certificate pursuant
 - 23 to this chapter shall pay the following respective fee:
 - 24 Master Installer \$ 20.00
 - 25 Journeyman Installer \$ 20.00
 - 26 Soil Evaluator \$ 20.00
 - 27 Multiple category \$ 20.00

5		A base fee and a per lot fee shall be paid for Health

9		Maximum combined base fee and per lot fee	\$1,000.00	

10 (j) All fees are payable to the City of Lincoln and shall be credited to the Health Fund.
11 No fees will be refunded.

12 Section 2. That Section 24.42.110 of the Lincoln Municipal Code be amended to
13 read as follows:

14 **24.42.110 Fees.**

- 15 (a) Fee for evaluation and review of Property Transfer
- 16 Inspector reports and any necessary site visits by Health Director . ~~\$75.00~~ \$80.00
- 17 (b) Property Transfer Inspector permit fees:
- 18 On-site Wastewater Treatment System
- 19 (OWWTS) Property Transfer Inspector
- 20 \$20.00
- 21 On-site Waste Supply System (OWSS)
- 22 Property Transfer Inspector
- 23 \$20.00
- 24 Both OWWTS & OWSS
- 25 \$30.00

26 All fees are payable to the Lincoln-Lancaster County Health Department and shall be
27 credited to the Health Fund. No fees will be refunded.

28 Section 3. That Sections 24.38.070 and 24.42.110 of the Lincoln Municipal Code
29 as hitherto existing be and the same are hereby repealed.

1 Section 4. That this ordinance shall take effect and be in force from and after its
2 passage and publication according to law.
