

Annexation No. 08010 - 70th and Pine Lake Road

ORDINANCE NO. _____

1 AN ORDINANCE annexing and including the below described land as part of the
 2 City of Lincoln, Nebraska and amending the Corporate Limits Map attached to and made a part
 3 of Ordinance No. 18208, to reflect the extension of the corporate limits boundary of the City of
 4 Lincoln, Nebraska established and shown thereon.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That the land legally described as follows:

7 Lots 52, 53, 19, 18, 29, 30, 65, 48, 47, Lots 76-79, and remaining
 8 portions of Lots 10 and 46 Irregular Tracts, all located in Section
 9 21, Township 9 North, Range 7 East of the 6th P.M.; Lots 56, 77,
 10 and that portion of Lot 71 Irregular Tracts lying outside the City
 11 limits, all located in Section 15, Township 9 North, Range 7 East
 12 of the 6th P.M.; the remaining portion of Lot 16 I.T. located in
 13 Section 22, Township 9 North, Range 7 East of the 6th P.M.; Lots
 14 1-5, Block 1, Lot 1, Block 2, Lots 1-4 and 6-10, Block 3 and Lots 1-
 15 10, Block 4, Clarendon Hills Addition; Lots 1-5, Block 1, Lots 1-11,
 16 Block 2, Lots 1-7, Block 3, Lots 1-5 and Lot 8, Block 4, Clarendon
 17 Hills 1st Addition, Lots 1 and 2, Stauffer Addition; that portion of
 18 Outlot D, Grand Terrace Addition outside the City limits; Lot 1,
 19 Block 1, Lot 1, Block 2, Lots 1-6, Block 3, Amber Hill Estates; Lots
 20 1-4, Block 1, Lots 1 and 2, Block 2, Amber Hill Estates 1st
 21 Addition; Lots 1 and 2, Amber Hill Estates 2nd Addition; Lots 1-5,
 22 Block 1, Portsche Heights 3rd Addition; and Lots 1 and 2,
 23 Portsche Heights 4th Addition; and adjacent rights-of-way and
 24 railroad right-of-way, located in Section 22, Township 9 North,
 25 Range 7 East of the 6th P.M.; all located in Lancaster County,
 26 Nebraska, generally located at S. 70th Street and Pine Lake
 27 Road;

28 be and they hereby are annexed and included within the corporate limits of the City of Lincoln,
 29 Nebraska and are hereby made a part of the City of Lincoln, Nebraska for all purposes.

30 Section 2. That the "Corporate Limits Map" attached to and made a part of
 31 Ordinance No. 18208, be and it is hereby amended to extend the corporate limits boundary of

1 the City of Lincoln, Nebraska, to reflect the above extension of the corporate limits boundary of
2 the City of Lincoln. Said map amendment is shown on Attachment "A" which is attached hereto
3 and made a part hereof by reference.

4 Section 3. Pursuant to Article VII, Section 7 of the City Charter, this ordinance
5 shall be posted on the official bulletin board of the City, located on the wall adjoining the City
6 Clerk's office at 555 S. 10th Street, in lieu of and in place of newspaper publication with notice
7 of passage and such posting to be given by publication one time in the official newspaper by the
8 City Clerk. This ordinance shall take effect and be in force from and after its passage and
9 publication as herein and in the City Charter provided.
