

Annexation No. 08014 - 1st and Van Dorn

ORDINANCE NO. \_\_\_\_\_

1           AN ORDINANCE annexing and including the below described land as part of the  
2 City of Lincoln, Nebraska and amending the Corporate Limits Map attached to and made a part  
3 of Ordinance No. 18208, to reflect the extension of the corporate limits boundary of the City of  
4 Lincoln, Nebraska established and shown thereon.

5           BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6           Section 1. That the land legally described as follows:

7           All of Lots 74 I.T. and 91 I.T. and the remainder of Lot 92 I.T. not  
8 previously annexed, located in Section 2, Township 9 North,  
9 Range 6 East of the 6th P.M.; and also those portions of Lot 13  
10 I.T. the State of Nebraska property and B.N.S.F. railroad right-of-  
11 way lying north of the north line of vacated Pioneers Boulevard  
12 and west of the east line of the B.N.S.F. railroad right-of-way not  
13 previously annexed in Section 2, Township 9 North, Range 6 East  
14 of the 6th P.M.; and Lots 36 I.T., 5 I.T., 17 I.T., and 6 I.T., in  
15 Section 11, Township 9 North, Range 6 East of the 6th P.M.; that  
16 portion of the West Half of the Northeast Quarter of said Section  
17 11 not previously annexed and all railroad right-of-way lying  
18 easterly of the west line of Lot 6 I.T. extended southerly to the  
19 westerly line of Lot 10 I.T. in said Section 11; all in Lancaster  
20 County, Nebraska, generally located at S. 1st Street and Van  
21 Dorn Street and S. 6th Street and Pioneers Boulevard;

22 be and they hereby are annexed and included within the corporate limits of the City of Lincoln,  
23 Nebraska and are hereby made a part of the City of Lincoln, Nebraska for all purposes.

24           Section 2. That the "Corporate Limits Map" attached to and made a part of  
25 Ordinance No. 18208, be and it is hereby amended to extend the corporate limits boundary of  
26 the City of Lincoln, Nebraska, to reflect the above extension of the corporate limits boundary of  
27 the City of Lincoln. Said map amendment is shown on Attachment "A" which is attached hereto  
28 and made a part hereof by reference.

1                   Section 3. Pursuant to Article VII, Section 7 of the City Charter, this ordinance  
2 shall be posted on the official bulletin board of the City, located on the wall adjoining the City  
3 Clerk's office at 555 S. 10th Street, in lieu of and in place of newspaper publication with notice  
4 of passage and such posting to be given by publication one time in the official newspaper by the  
5 City Clerk. This ordinance shall take effect and be in force from and after its passage and  
6 publication as herein and in the City Charter provided.
