RE: Report of Claims Against the City of Lincoln for March 16 through March 31, 2009

Dear Mayor & Council:

The following is a report of claims against the City of Lincoln which have been disposed of, or are pending, for the period of March 16 through March 31, 2009. This report will describe the claims and the dispositions or status of these claims.

## **DENIED CLAIMS:**

**Linda Gerlach** filed a claim during the month of February, 2009, in an unspecified amount for damage allegedly incurred to windshield of vehicle when struck by a rock from a City sand truck. This claim has been reviewed by this office and has been **denied**.

**Rodney L. Geis** filed a claim during the month of February, 2009, in an unspecified amount for damage allegedly incurred to sod and sprinkler heads as the result of snow removal activity. This claim has been reviewed by this office and has been **denied**.

**Ritchie Bros.** filed a claim during the month of February, 2009, in an unspecified amount for damage allegedly incurred to sod and sprinkler heads as the result of snow removal activity. This claim has been reviewed by this office and has been **denied**.

**Daphne Sponey-Leybold** filed a claim during the month of March, 2009, in the amount of \$864.15 for damages incurred to vehicle as the result of alleged improper maintenance of street. This claim has been reviewed by this office and has been **denied**.

**Servant Cab Co.** filed a claim during the month of March, 2009, in the amount of \$3,148.28 for damages incurred to vehicle as the result of an accident involving a City snowplow. This claim has been reviewed by this office and has been **denied**.

**Jerry C. Martin** filed a claim during the month of March, 2009, in an unspecified amount for damage allegedly incurred to sod and sprinkler system as the result of snow removal activity. This claim has been reviewed by this office and has been **denied**.

(Burden Enterprises, Insured; Claim #950379) filed a worker's compensation subrogation claim during the month of October, 2008, in an unspecified amount for medical expenses paid on behalf of Insured's employee who was involved in a motor vehicle accident involving a City vehicle. This claim is under review and is **pending**.

**Josh and Melissa McCurley** filed a claim during the month of March, 2009, in the amount of \$9,482.51 for alleged damages incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

**Carlos Carpio** filed a claim during the month of March, 2009, in the amount of \$53.00 for reimbursement of tow fee. This claim is under review and is **pending**.

**John and Lisa Showalter** filed a claim during the month of March, 2009, in the amount of \$5,171.81 for alleged damages incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

**State Farm Insurance (Mitch L. McArtor, Insured)** filed a claim during the month of March, 2009, in an unspecified amount for damage incurred to Insured's vehicle as the result of an accident involving a Parks and Recreation vehicle. This claim is under review and is **pending**.

**Linda Gropp** filed a claim during the month of March, 2009, in the amount of \$176.55 for expense incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

**Stephanie Bales** filed a claim during the month of March, 2009, for damage allegedly incurred to sprinkler system when sidewalk was replaced. This claim is under review and is **pending**.

## PENDING TORT LITIGATION:

**Ettamae Branstetter** filed a claim during the month of July, 2005, in an unspecified amount for injury incurred when the automated door at the Eisley Library struck the claimant as she was exiting the Library causing her to fall. Claimant was a volunteer at the Library. This claim was reviewed by this office and denial of this claim was approved by the City Council on March 6, 2006. A Complaint was filed in the Lancaster County District Court on April 19, 2006. Litigation is **pending**.

Troy Stonacek and Shari Stonacek, Bradley Sheaff and Jennifer Sheaff, George Bristol and Lori Bristol filed claims during the month of July, 2005, for alleged damages incurred as the result of alleged failure to provide claimants with proper base flood elevations prior to construction of claimants' homes. These claims were withdrawn on February 3, 2006, and claimants filed suit in the Lancaster County District Court naming Home Real Estate, Merle Jahde, LPT, Inc., Lyle Loth, and the City of Lincoln as defendants. Litigation is **pending**.

**Beth Hollon** filed a claim during the month of January, 2007, in an unspecified amount for injury incurred when claimant allegedly fell in a hole in the right-of-way. This claim was reviewed by this office and denial of this claim was approved by the City Council on February 26, 2007. A suit was filed in the Lancaster County District Court on August 28, 2007. Litigation is **pending**.

**Steve Cummings** filed a claim during the month of December, 2006, in an unspecified amount for alleged injury incurred when claimant was a passenger on a StarTran bus. This claim was reviewed by this office and denial of this claim was approved by the City Council on January 22, 2007. A suit was filed in the Lancaster County District Court on October 5, 2007. Litigation is **pending**.

**Deborah Chinnow, Conservator of Jena I. Van Groningen** filed a claim during the month of April, 2007, for injuries incurred when Jena was struck by a police vehicle as she was crossing a city street. This claim was withdrawn by counsel for claimant on October 30, 2007, and suit was filed in the Lancaster County District Court on November 2, 2007. Litigation is **pending**.

**Jeffrey Harris** filed a claim during the month of January, 2007, in the amount of \$900,000 for injury incurred when a manhole cover allegedly flipped up and struck claimant. This claim was denied by this office for the reason there was not sufficient evidence to support the claim. Denial of this claim was approved by the City Council on June 4, 2007. A suit was filed in the Lancaster County District Court on October 18, 2007. Litigation is **pending**.

Charles L. Teeters and Kristina D. Teeters filed a claim during the month of October, 2005, for damage incurred to vehicle and alleged injuries incurred to Kristina Teeters and the minor children of Charles and Kristina Teeters, Walter, Marjorie, and Charles E.F. Teeters, as the result of an accident involving a StarTran bus. The property damage portion of this claim was settled in the amount of \$2,879.16, however, required medical records to support the personal injury claims were not provided, therefore, the personal injury claims were denied. Denial was approved by the City Council on May 14, 2007. A suit was filed in the Lancaster County District Court. Litigation is **pending**.

**Rita J. Choquette, Personal Representative of the Estate of Emy C. Choquette** filed a claim during the month of October, 2007, in the amount of \$1,200,000. Claimant alleges that Lincoln Fire and Rescue personnel failed to provide required services. This claim was withdrawn by counsel for claimant and suit has been filed in the Lancaster County District Court on July 11, 2008. Litigation is **pending**.

**Kerry Rupe** filed a claim during the month of February, 2008, in the amount of \$25,000 for alleged injury incurred as the result of an accident involving an Aging van. A suit was filed in the Lancaster County Court on September 2, 2008. Litigation is **pending**.

**Laura Sheldon** filed a claim during the month of April, 2008, in the amount of \$500,000 for alleged injury incurred as the result of fall in alley at 4750 Calvert. This claim was withdrawn by counsel for claimant on November 4, 2008, and suit was filed in the Lancaster County District Court on November 24, 2008. Litigation is **pending**.

**Susan Chocholousek** filed a claim during the month of December, 2006, in the amount of \$43,314.00 for alleged injury incurred when claimant was a passenger on a StarTran bus. This claim was withdrawn and suit was filed in the Lancaster County District Court on December 17, 2008. Litigation is **pending**.

**Sandra Eadie** filed a claim during the month of April, 2008, in the amount of \$200,000 for injury allegedly incurred when the tires of the bicycle claimant was riding slid in mud that had accumulated on the street near a construction site causing claimant to fall from the bicycle. A suit was filed in the Lancaster County District Court on December 24, 2008. Litigation is **pending**.

**Rasta Kennedy** filed a claim during the month of August, 2007, in the amount of \$1,654.14 for damage incurred to vehicle as the result of an accident involving a City vehicle. A notice of tort claim was received in the City Clerk's Office on January 15, 2008, from counsel for claimant stating a demand for damages in the amount of \$100,000 as a result of the accident. This claim was withdrawn by counsel for claimant on July 30, 2008, and suit was filed in the Lancaster County District Court on January 13, 2009. Litigation is **pending**.

**Deandre Brown** filed a claim during the month of July, 2008, in the amount of \$550.00 for alleged property damage incurred as the result of action by Lincoln police. Denial of this claim was approved by the City Council on September 8, 2008. A suit was filed in the Lancaster County Court on February 19, 2009. Litigation is **pending**.

**Robert Niemeyer, Personal Representative of the Estate of Alvin Niemeyer** filed a claim during the month of July, 2008, in the amount of \$1,000,000. Claimant alleges that a motor vehicle accident which caused injuries that allegedly led to the death of Alvin Niemeyer was caused by the negligence of the City of Lincoln in failing to maintain weeds at an intersection. This claim was withdrawn by counsel for claimant on February 27, 2009. Claimant filed suit in the Lancaster County District Court against Scott Anderson, the City of Lincoln and Lancaster County. Litigation is **pending**.
