**Amendment to Agreement for  
Business Card and Letterhead Printing, Bid No. 09-219  
City of Lincoln/Lancaster County/ Lincoln-Lancaster County Public Building Commission**

This Amendment is hereby entered into on this 11 day of November, 2011, by and between **Cornerstone Printing and Imaging, 201 North 14<sup>th</sup> St., Lincoln, NE 68508** (hereinafter "Contractor") and the **City of Lincoln, Lancaster County and Lincoln-Lancaster County Public Building Commission** (hereinafter "Owners"), for the purpose of renewing the Agreement C-09-0636, dated December 14, 2009, and Resolution A-85683, dated January 14, 2010, (the "Agreement"), for **Business Card and Letterhead Printing, Bid No. 09-219**, which is made a part of this amendment by this reference.

WHEREAS, the original term of the Agreement is **January 14, 2010 thru January 13, 2012**, with the option to renew for one (1) additional two (2) year period; and

WHEREAS, the parties wish to renew the agreement for **January 14, 2012 thru January 13, 2014**;

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants contained in the Agreement, under County Contract C-09-0636 and City Resolution A-85683, and stated herein the parties agree as follows:

- 1) The Agreement shall be renewed for an additional two (2) year term, **January 14, 2012 thru January 13, 2014**.
- 2) All other terms of the Agreement, not in conflict with this Amendment, shall remain in full force and effect.

The Parties do hereby agree to all the terms and conditions of this Amendment. This Amendment shall be binding upon the parties, their heirs, administrators, executors, legal and personal representatives, successors, and assigns.
