<p>Discussion (Including Relationship to other Council Actions)</p> <p>In 2011, the Parks and Recreation Department proposed a code amendment that would allow alcoholic beverages to be served in conjunction with rental use of Auld Pavilion. In this instance, Parks and Recreation would have been responsible for managing rental of the facility and receiving rental revenue.</p> <p>Under the proposed amendment, the Parks & Recreation Department would issue a request for proposal for a private business to manage rental of Auld Pavilion and to provide catering services, including serving of alcoholic beverages.
