1 WHEREAS, in accordance with Section 14.20.020 of the Lincoln Municipal Code, the  
2 fee the Planning Department may charge for application reviews for street and alley vacations  
3 under Chapter 14.20 of the Lincoln Municipal Code must be approved by resolution of the City  
4 Council; and

5 WHEREAS, in accordance with Section 26.33.010 of the Lincoln Municipal Code, the  
6 fees which the Planning Department may charge for application reviews under Title 26 of the  
7 Lincoln Municipal Code (Land Subdivision Ordinance) must be approved by resolution of the City  
8 Council; and

9 WHEREAS, in accordance with Section 27.80.010 of the Lincoln Municipal Code, the  
10 fees which the Planning Department may charge for application reviews under Title 27 of the  
11 Lincoln Municipal Code (Zoning Ordinance) must be approved by resolution of the City Council; and

12 WHEREAS, the Planning Director is requesting authorization to collect an increased filing  
13 fee to review an application to amend the Lincoln-Lancaster County Comprehensive Plan; and

14 WHEREAS, the Planning Department has proposed the Fee Schedule for application  
15 reviews under Chapter 14.20, Title 26, and Title 27 of the Lincoln Municipal Code and amendments  
16 to the Lincoln-Lancaster County Comprehensive Plan attached hereto marked as Attachment A and  
17 recommends its adoption; and

18 WHEREAS, the proposed fees are before the City Council for its consideration and  
19 approval; and

20 WHEREAS, the City Council finds that the proposed fees, based on the reasonable costs  
21 of providing staff to review the applications, represent reasonable maximum fees to be charged for  
22 said reviews.

1           NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lincoln,  
2 Nebraska that the Fee Schedule for application reviews under Chapter 14.20, Title 26, and Title 27  
3 of the Lincoln Municipal Code and amendments to the Lincoln-Lancaster County Comprehensive  
4 Plan, attached hereto marked as Attachment A and made a part hereof by reference, is hereby  
5 approved.

6           BE IT FURTHER RESOLVED that the fees in the attached fee schedule shall take effect  
7 on October 1, 2012.

8           BE IT FURTHER RESOLVED that this Resolution supercedes and replaces the fee  
9 schedule for application reviews under Chapter 14.20, Title 26 and Title 27 of the Lincoln Municipal  
10 Code and amendments to the Lincoln-Lancaster County Comprehensive Plan established by  
11 Resolution No. A-84966.
