ORDINANCE NO. _____

1 AN ORDINANCE annexing and including the below described land as part
 2 of the City of Lincoln, Nebraska and amending the Corporate Limits Map attached to
 3 and made a part of Ordinance No. 18208, to reflect the extension of the corporate limits
 4 boundary of the City of Lincoln, Nebraska established and shown thereon.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That the land legally described as follows:

7 All of Lot 38 Irregular Tract except for a triangular portion of
 8 Lot 38 described as follows: from a point 50 feet south of
 9 the centerline of Havelock Avenue at the northeast corner of
 10 Lot 38 I.T. which is the point of beginning; thence 100 feet
 11 west along the south right-of-way line of Havelock Avenue;
 12 thence southeast 87.02 feet at an angle of 41 degrees 23
 13 minutes 39 seconds from the south line of Havelock Avenue
 14 to a point on the east line of Lot 38 I.T.; thence northeast
 15 67.23 feet at an angle of 79 degrees 43 minutes to the point
 16 of beginning; located in the North Half of Section 11,
 17 Township 10 North, Range 7 East of the 6th P.M., Lancaster
 18 County, Nebraska;

19 be and it hereby is annexed and included within the corporate limits of the City of
 20 Lincoln, Nebraska and is hereby made a part of the City of Lincoln, Nebraska for all
 21 purposes.

22 Section 2. That the "Corporate Limits Map" attached to and made a part
 23 of Ordinance No. 18208, be and it is hereby amended to reflect the above extension of
 24 the corporate limits boundary of the City of Lincoln. Said map amendment is shown on
 25 Attachment "A" which is attached hereto and made a part hereof by reference.

1 Section 3. Pursuant to Article VII, Section 7 of the City Charter, this
2 ordinance shall be posted on the official bulletin board of the City, located on the wall
3 across from the City Clerk's office at 555 S. 10th Street, in lieu of and in place of
4 newspaper publication with notice of passage and such posting to be given by
5 publication one time in the official newspaper by the City Clerk. This ordinance shall
6 take effect and be in force from and after its passage and publication as herein and in
7 the City Charter provided.

8 Section 4. That pursuant to the Lincoln City Charter Article IV, Section 2a,
9 Neb. Rev. Stat. § 15-247 (Reissue 2007) and Neb. Rev. Stat. § 32-553 et seq. (Reissue
10 2008) the land annexed above shall be assigned to City Council District #1.

11 Section 5. That the City Clerk is directed to return a certified copy of this
12 Ordinance to the Director of the Planning Department. The Planning Director is directed
13 to transmit the Ordinance and list of property owners included within the area annexed
14 to the Lancaster County Election Commission.
