ORDINANCE NO. \_\_\_\_\_

1           AN ORDINANCE annexing and including the below described land as part  
 2 of the City of Lincoln, Nebraska and amending the Corporate Limits Map attached to  
 3 and made a part of Ordinance No. 18208, to reflect the extension of the corporate limits  
 4 boundary of the City of Lincoln, Nebraska established and shown thereon.

5           BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6           Section 1. That the land legally described as follows:

7           All of Lot 69 Irregular Tract located in the Southwest Quarter  
 8 of Section 27, Township 9 North, Range 7 East of the 6th  
 9 P.M., Lancaster County, Nebraska;

10 be and it hereby is annexed and included within the corporate limits of the City of  
 11 Lincoln, Nebraska and is hereby made a part of the City of Lincoln, Nebraska for all  
 12 purposes.

13           Section 2. That the "Corporate Limits Map" attached to and made a part  
 14 of Ordinance No. 18208, be and it is hereby amended to reflect the above extension of  
 15 the corporate limits boundary of the City of Lincoln. Said map amendment is shown on  
 16 Attachment "A" which is attached hereto and made a part hereof by reference.

17           Section 3. Pursuant to Article VII, Section 7 of the City Charter, this  
 18 ordinance shall be posted on the official bulletin board of the City, located on the wall  
 19 across from the City Clerk's office at 555 S. 10th Street, in lieu of and in place of  
 20 newspaper publication with notice of passage and such posting to be given by  
 21 publication one time in the official newspaper by the City Clerk. This ordinance shall

1 take effect and be in force from and after its passage and publication as herein and in  
2 the City Charter provided.

3 Section 4. That pursuant to the Lincoln City Charter Article IV, Section 2a,  
4 Neb. Rev. Stat. § 15-247 (Reissue 2007) and Neb. Rev. Stat. § 32-553 et seq. (Reissue  
5 2008) the land annexed above shall be assigned to City Council District #2.

6 Section 5. That the City Clerk is directed to return a certified copy of this  
7 Ordinance to the Director of the Planning Department. The Planning Director is directed  
8 to transmit the Ordinance and list of property owners included within the area annexed  
9 to the Lancaster County Election Commission.
