1 AN ORDINANCE repealing Section 5.04.120 of the Lincoln Municipal Code  
2 relating to prohibiting minors on licensed premises which sell or dispense alcoholic liquor at retail  
3 for consumption on the premises after 9:00 p.m.

4 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

5 Section 1. That Section 5.04.120 of the Lincoln Municipal Code be and the same is  
6 hereby repealed.

7 ~~5.04.120 Minors; Prohibited on Premises.~~

8 ~~—(a) After the hour of 9:00 p.m., it shall be unlawful for any minor under the age of sixteen~~  
9 ~~years to be in the premises as defined in this title, which are licensed under the Nebraska Liquor~~  
10 ~~Control Act for the sale or dispensing of alcoholic liquor at retail for consumption on the premises,~~  
11 ~~unless accompanied by a person who is at least twenty-one years of age.~~

12 ~~—(b) After the hour of 9:00 p.m., it shall be unlawful for any person, firm, partnership or~~  
13 ~~corporation holding a license under the Nebraska Liquor Control Act for the sale or dispensing of~~  
14 ~~alcoholic liquor at retail for consumption on the premises to allow a minor under the age of sixteen~~  
15 ~~years to be in premises as defined in this title, where alcoholic liquor is sold or dispensed by such~~  
16 ~~licensee, unless accompanied by a person who is at least twenty-one years of age.~~

17 ~~—(c) This section shall not apply to participating minors listed on the roster for a particular~~  
18 ~~teen night event properly permitted under Chapter 5.14 of this code but only during the times and~~  
19 ~~places specifically permitted for the particular teen night event under the applicable permit.~~

1 ~~—— (d) — This section shall not apply to any person, firm, partnership, or corporation holding~~  
2 ~~a license under the Nebraska Liquor Control Act for the sale or dispensing of alcoholic liquor at~~  
3 ~~retail for consumption on the premises conducting or operating a teen night event properly permitted~~  
4 ~~under Chapter 5.14 of this code as it applies to minors listed on the roster for a particular teen night~~  
5 ~~and then only during the times and places specifically permitted for the particular teen night event~~  
6 ~~under the applicable permit.~~

7 Section 2. That this ordinance shall take effect and be in force from and after passage  
8 and publication in one issue of a daily or weekly newspaper of general circulation in the City,  
9 according to law.
