As Mayor, I have worked with the community on our common goal of making Lincoln the healthiest City in the nation. A key partner in reaching that goal is our Lincoln-Lancaster County Health Department. 2018 has been another year of accomplishments for Health Department employees, the Board of Health, and those serving on the Department's advisory committees.

As our City continues to grow, the need for Health Department services has grown. One major growth area is dental health. In the past year, staff saw 13,384 visits by 3,703 patients; 70 % of these were children. To meet the increasing need, facilities and hours were added.

Lincoln's Hazardous Waste Center has helped the City reach its goal of diverting 100,000 lbs. of toxic material from the landfill annually. This year, the public made their homes safer by taking 105,000 lbs. of household hazardous waste to the Center and community collection events.

Child passenger safety is a priority of the Department. With the help of volunteer certified child passenger safety technicians, hundreds of children had car seats fitted. To meet this growing need, the Department partnered with Lincoln Fire and Rescue to provide more technicians and service sites.

This year, my wife and I joined the legion of residents who have a pet dog. Our Animal Control Division keeps our pets and the public healthy by promoting rabies vaccinations and providing licenses to more than 63,000 cats and dogs.

Another priority is providing access to affordable health care. Our Health Department works with community partners to connect people to a medical home. In the past five years, 27,960 individuals from the age of 19 to 64 have been connected to health insurance.

The Department also works closely with government access channels, LNKTV City and LNKTV Health to provide important health information.

In this annual report, you'll find more highlights from the Department employee's busy year. I want to thank them for their hard work, dedication, and commitment.
