MOTION: Hudkins moved and Heier seconded approval of the minutes of July 6, 1999. On call Campbell, Hudkins, Heier, Workman and Steinman voted aye. Motion carried.

MOTION: Workman moved and Heier seconded approval. On call Heier, Campbell, Steinman, Hudkins and Workman voted aye. Motion carried.

3) **PUBLIC HEARINGS:**

A. County Miscellaneous 99001, requested by Jerry Malek, to vacate Lot 2 of Glenwood Acres final plat, located at 176th and Holdrege Streets in Lancaster County, Nebraska. (19991256) (19991338)

The Chair opened the public hearing and asked if anyone wished to testify in favor of the request.

The County Clerk administered the oath to Jerry Malek, applicant of County Miscellaneous 99001.

Malek stated the purpose of the request was to allow the creation of a combined lot with an adjoining irregular tract.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

MOTION: Steinman moved and Heier seconded approval of Resolution 99-1338; County Miscellaneous 99001: to vacate Lot 2 of Glenwood Acres Final Plat, located at 176th and Holdrege Streets in Lancaster County, Nebraska. On call Steinman, Workman, Heier, Campbell and Hudkins voted aye. Motion carried.

B. A Corporate Manager application from Randall C Carlson in connection with a Class E (Beer Off Sale Only) and a Class M (Bottle Club) liquor license for Corporate Golf Marketing Inc dba/HiMark Golf Club located at 9003 Pioneers Boulevard in Lancaster County, Nebraska. (19991285) (19991345) (19991301) (19991358)

The Chair opened the public hearing and asked if anyone wished to testify in favor of the application.

The County Clerk administered the oath to Randall C Carlson, applicant.

Carlson stated that he is the general manager at HiMark Golf Course and explained that he had a liquor license in his name for an establishment in Grand Island for approximately six years.

He also noted he will be enrolling in the "Responsible Hospitality" class within the next six months.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

The Chair also noted that action will be taken on Tuesday, July 20, 1999.

C. An addition to licensed premise to include a Morton building in connection with a liquor license for the Nebraska State Board of Agriculture dba/"Nebraska State Fair" located at 1800 State Fair Park Drive. (19991284) (19991302) (19991357) (19991355)

The Chair opened the public hearing and asked if anyone wished to testify in favor of the addition.

The County Clerk administered the oath to Sharon Schrock, representative for the Nebraska State Board of Agriculture.

Schrock explained that their liquor license includes many different buildings which are included in one license. She stated they would like to include the Morton building in their license to allow for simulcasting at that location during the State Fair and to hold meetings, small parties and receptions in the future. By adding the building to their existing license they would not need to apply for a Special Designated License for each event.

Hudkins stated he appreciated knowing about the nature of individual functions and the people involved. He said he would prefer that the County Board continue to exercise that control.

In response to a question asked by Workman, Schrock stated the simulcasting would be moved back to the grandstand area after the State Fair is over.

Heier inquired about restroom facilities.

Schrock stated they are currently adding restrooms and a room which can be used as an office.

In response to a question asked by Campbell, Terry Wagner, County Sheriff, stated that he was not aware of any problems regarding minors in the grandstand area.

Wagner stated that the Nebraska State Board of Agriculture does a good job in relation to security and that his office has worked with them on larger events.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

4) **NEW BUSINESS:**

A. An application for a Special Designated License from the Nebraska State Board of Agriculture to hold the "Budweiser Beer School" during the Nebraska State Fair, beginning Friday, August 27 and ending Monday, September 6, 1999 from 9 a.m. to midnight each day, with the exception of Sundays when the hours will be Noon to Midnight. (19991124) (19991215) (19991214) (19991135)

Sharon Schrock, representative for the Nebraska State Board of Agriculture, explained that the "Budweiser Beer School" is a way to educate individuals regarding the history of brewing, ingredients used, the brewhouse process, the different types of beer and a tasting session.

Workman expressed strong concerns regarding the Nebraska State Fair having a beer school on its premises.

MOTION:

Workman moved and Hudkins seconded denial of the application for a Special Designated License from the Nebraska State Board of Agriculture to hold the "Budweiser Beer School" during the Nebraska State Fair, beginning August 27 and ending September 6, 1999 from 9 a.m. to Midnight each day, with the exception of Sundays when the hours will be Noon to Midnight.

Heier asked why the beer school was being allowed to set up across from the 4-H building.

Schrock stated that particular location would allow for enough space for the two semi's and the accompanying stairways. She added that the display could be moved to the same location as two years ago.

In response to a question asked by Campbell, Terry Wagner, County Sheriff, stated he was not aware of any problems with the school when it was at the State Fair two years ago.

Workman stated he is concerned about the message that the beer school sends.

Campbell asked if other individuals display alcoholic items during the State Fair.

Schrock stated they have a wine and beer competitions.

Campbell suggested deferring action to obtain more information and to allow for discussion of an alternative location.

Heier concurred with Campbell.

Hudkins stated he felt it was very inappropriate to have the school located near the 4-H building.

ROLL CALL: Workman and Hudkins voted aye. Steinman, Campbell and Heier voted

no. Motion failed.

MOTION: Steinman moved and Heier seconded to approve the application for a Special Designated License from the Nebraska State Board of Agriculture to hold the

"Budweiser Beer School" during the Nebraska State Board of Agriculture to hold the "Budweiser Beer School" during the Nebraska Stat Fair, beginning August 27 and ending September 6, 1999 from 9 a.m. to Midnight each day, with the exception of Sundays when the hours will be Noon to Midnight and with the condition that it be moved to a new location away from the Youth Complex, possibly at the

same location of two years ago.

AMENDMENT: Hudkins moved and Heier seconded to amend the previous motion to

include that no free liquor samples be offered.

ROLL CALL TO AMENDMENT: Heier and Hudkins voted aye. Campbell, Steinman and

Workman voted no. Motion failed.

Steinman withdrew her previous motion and the seconder agreed.

Campbell stated she would like to hear from Budweiser regarding alternatives and possible restrictions.

MOTION: Heier moved and Hudkins seconded to defer action on the application for a Special Designated License from the Nebraska State Board of Agriculture to hold the "Budweiser Beer School" during the Nebraska State Fair, beginning August 27 and ending September 6, 1999 from 9 a.m. to Midnight each day, with the exception of Sundays when the hours will be Noon to Midnight for one week, two weeks if needed, to obtain additional information and to allow for further review. On call Steinman, Workman, Heier, Campbell and Hudkins voted aye. Motion carried.

B. An application for a Special Designated License from the Wine Merchants Inc. to hold a wedding reception on Sunday, July 25, 1999 from 3 p.m. to 11 p.m. at Boss Hogs banquet facility located at 6305 West Adams Street in Lancaster County, Nebraska. (19991258) (19991294) (19991287) (19991286)

MOTION: Steinman moved and Heier seconded approval. On call Heier, Workman, Hudkins, Campbell and Steinman voted aye. Motion carried.

C. An agreement with the State of Nebraska, Department of Roads for road construction on Fletcher Avenue between Northwest 112th and Northwest 126th Streets and on West Adams Street from Northwest 126th Street up to the Game and Parks recreation facility at Pawnee Lake, at an estimated cost to the County of approximately \$160,000. (Project SRR-55(126) (19991352)

MOTION: Steinman moved and Heier seconded approval. On call Campbell, Steinman, Workman, Heier and Hudkins voted aye. Motion carried.

D. An agreement with the Village of Raymond to allow a temporary easement to Raymond for maintaining and disassembling a water tower. The easement will end 90 days after a new water tower is built. (19991353)
