Pat Kant, Personnel Department, appeared and discussed the following changes to the policy:

* Representatives on the Commissioners' Award of Excellence Committee will be appointed on a calendar year basis.

- * Cost incurred to purchase a U.S. Savings Bond will be charged to the employee's department budget.
- **MOTION:** Steinman moved and Heier seconded approval of the revised policy regarding the Lancaster County Commissioners' Award of Excellence Program. On call Workman, Campbell, Steinman and Heier voted aye. Motion carried.

- **MOTION:** Steinman moved and Workman seconded approval of an application for a Special Events Permit from Team Kaos Cycling Club to hold a bicycle race on roads around Branched Oak Lake on September 19, 1999, beginning at 8 a.m. subject to the conditions as set forth by the County Engineer and the Sheriff. On call Steinman, Workman, Heier and Campbell voted aye. Motion carried.
 - B. Resolution authorizing and providing for the issuance of Limited Tax Building Bonds, Series 1999 of the County of Lancaster, Nebraska, in the principal amount of not to exceed \$10,250,000 for the purpose of paying the costs of constructing, equipping and furnishing a juvenile detention facility for the County. (19991680)

Lauren Wismer, Cline Williams law firm and bond counsel, appeared and explained the resolution will authorize the issuance of limited tax building bonds on behalf of the County to finance costs which have not yet accumulated from the 5.2 cent tax levy. He stated the preliminary official statement and notice of sale have been mailed and the bonds are to be sold at a public sales in two weeks.

Al Eveland, financial advisor with Ameritas Investment Corp, stated they are anticipating a great deal of interest on the part of perspective bidders.

In response to a question asked by Workman regarding interest rates, Eveland stated they anticipate the rate will be under 4.5 percent.

For the record, Heier stated he is represented by legal counsel from Cline Williams law firm.

MOTION: Steinman moved and Heier seconded approval of Resolution 99-1680 authorizing and providing for the issuance of Limited Tax Building Bonds, Series 1999 of the County of Lancaster, Nebraska, in the principal amount of not to exceed \$10,250,000 for the purpose of paying the cost of constructing, equipping and furnishing a juvenile detention facility for the County. On call Steinman, Workman, Campbell and Heier voted aye. Motion carried.

- C. An agreement with the State of Nebraska, Department of Roads to construct an asphalt overlay at Northwest 84th Street between U.S. Highway 6 and West Adams Street. The project, SRR-55(132), will be funded by State Recreation Road funds at 90 percent and the County will pay ten percent, which is \$22,780. (19991660)
- **MOTION:** Steinman moved and Heier seconded approval of an agreement with the State of Nebraska, Department of Roads. On call Heier, Workman, Campbell and Steinman voted aye. Motion carried.

D. A resolution for County maintenance of 5,472 feet in length of roads in the South Forty Subdivision and to include the following: (19991662)

- * 2,734 feet of West Bucks Drive
- * 689 feet of Southwest 34th Street
- * 337 feet of Southwest 37th Street

MOTION: Steinman moved and Workman seconded approval of Resolution 99-1662.

Workman noted that the County Engineering Department maintains 1,400 miles of road and Lancaster County's road mileage is the largest in the state.

- **ROLL CALL:** Campbell, Steinman, Workman and Heier voted aye. Motion carried.
 - E. Recommendation from the Purchasing Agent and the County Engineer to award a bid to Dobson Brothers Construction Company, in the amount of \$51,222.57, for salt dome paving in Sprague, Nebraska. (19991672)
- **MOTION:** Steinman moved and Heier seconded approval.

Workman commented that they received three bids ranging from \$51,222.57 to \$90,000.

- **ROLL CALL:** Heier, Workman, Steinman and Campbell voted aye. Motion carried.
 - F. A grant contract with Transfiguration, Inc. to provide services to persons with developmental disabilities from July 1, 1999 to June 30, 2000. Payments will be made quarterly by the County based upon reports from Transfiguration. (19991679)

Kerry Eagan, Chief Administrative Officer, explained that the contract was changed last year to add an insurance requirement and noted the change has been added to all of the contracts. A change was also made in the payment schedule from the beginning of the quarter to the end of the quarter.

- **MOTION:** Steinman moved and Heier seconded approval. On call Steinman, Heier, Workman and Campbell voted aye. Motion carried.
 - G. A contract between the Community Mental Health Center and Rick McNeese to provide up to 20 hours per week of specialized psychological services, at a rate of \$65 per hour, beginning July 1, 1999 and ending June 30, 2000. (19991678)
- **MOTION:** Heier moved and Steinman seconded approval. On call Workman, Campbell, Steinman and Heier voted aye. Motion carried.
 - H. A contract between the Community Mental Health Center and Dorie Reed to provide up to 20 hours per week of specialized psychological services, at a rate of \$65 per hour, beginning July 1, 1999 and ending June 30, 2000. (19991677)
- **MOTION:** Heier moved and Workman seconded approval. On call Workman, Heier, Campbell and Steinman voted aye. Motion carried.

I. A resolution determining final allocation of levy to all political subdivisions subject to the Lancaster County levy authority. (19991675)

Dave Kroeker, Budget and Fiscal Officer, stated the resolution allows the County to allocate up to 15 cents of the County's levy authority to subdivisions whose levy authority was taken away.

Workman noted that the Agricultural Society and the Railroad Transportation Safety District are countywide assessments.

MOTION: Workman moved and Heier seconded approval of Resolution 99-1675.

Campbell commented that she opposed previous action taken regarding additional money in the resolution for the Agricultural Society. She explained she supports the Agricultural Society, however, she feels the money could be returned to the taxpayer.

She explained by voting no on the current resolution before the County Board there could potentially be a 2 to 2 split vote. Entities must be notified by September 1st of the County Board's final action.

Campbell stated she would be voting in favor of the resolution stating that had Commissioner Hudkins been present, the intent would have been to approve the resolution. She reiterated that she still opposes the additional money.

Steinman stated she would be opposing the resolution, however, she does support the Agricultural Society.

ROLL CALL: Campbell, Heier and Workman voted aye. Steinman voted no. Motion carried.

J. Adoption of the Lancaster County and the Rural Library's budget for Fiscal Year 1999-2000. (19991674)

Dave Kroeker, Budget and Fiscal Officer, stated the Rural Library budget has no changes, however, the County budget should reflect the following changes:

- * Addition of \$4,519 for the group insurance increase on the joint City budgets
- * Addition of \$144,500 in a Contingency Fund for the increase on the County's group insurance
- * Addition of \$100,000 in the Building Fund for connection of the Downtown Senior Center to the skywalk system
- **MOTION:** Steinman moved and Heier seconded approval. On call Campbell, Steinman, Heier and Workman voted aye. Motion carried.

K. Authorization of the installation/replacement of the following traffic signs in Lancaster County, Nebraska: (19991636)

- * Remove hazard signs and weight limit signs from structure F-139
- * Remove hazard signs from structure F-141
- * Remove the side road warning sign and the dangerous intersection sign located south of Humphrey Street for northbound traffic

North 148th Street and Little Salt Road

- * Install yield signs for north and southbound traffic
- * Install a cross road warning sign on Little Salt Road approximately 1/10th of a mile west of North 148th Street for eastbound traffic

On North 84th Street south of Fletcher Avenue

* Install a 45 mile per hour speed limit sign for southbound traffic

On Agnew Road between North 112th Street and North 134th Street

* Install two bump signs with 35 mile per hour speed advisory plates for east and westbound traffic

In response to a question asked by Workman regarding the signage on Agnew Road, Larry Worrell, County Surveyor, stated they would be observing the bridge for further deterioration for approximately a one year period.
