# University of Nebraska Tech Park LLC

The Assessor recommended a value of \$330,784.

Tom Houston, attorney representing the University of Nebraska Tech Park LLC and the University of Nebraska Foundation, stated the property had been owned by the University of Nebraska Foundation until August 25, 1999. At that time it was transferred to the University of Nebraska Technology Park LLC. He stated the property has been ground leased to Southeast Community College who will be filing an application for its exempt purposes for the Nebraska Center for Excellence in Electronics. Houston stated a deed has been prepared to put the property back in the name of the University of Nebraska Foundation.

The Assessor stated the deed should be filed prior to December 31, 1999 and then the property would become exempt.

### INTRODUCTION OF PLANNING DIRECTOR, KATHLEEN SELLMAN:

Kathleen Sellman, Planning Director, was introduced by John Bradley and Mike DeKalb of the Planning Department.

## 3) **SPECIAL PRESENTATIONS:**

Gary Chalupa, County Veterans Service Officer; Rick Ringlein, Deputy County Veterans Service Officer and Jim Cada, Chair of the County Veterans Service Committee recognized Veterans Day.

Chalupa stated that Armistice Day was originated in 1926 in response to the strong desire to honor veterans of World War I. Twelve years later Congress designated that day as a national holiday and in 1954 Congress amended its act of 1938 by replacing the word armistice with the word veterans, marking November 11<sup>th</sup> as a national holiday and naming it Veterans Day to honor American veterans of all wars.

Rick Ringlein, Deputy County Veterans Service Officer, stated Veterans Day is a day to review memories of past honor and extraordinary courage, a day to celebrate peace and victories and day to honor the Americans sacrificed in war and pay our respects to those who survived.

Jim Cada, Chair of the County Veterans Service Committee, stated he appreciates the support that the County Board has given to the Veterans Service Officer, their office and staff and also noted they are doing an excellent job in assisting veterans. He invited the Board to attend a ceremony for veterans on Thursday, November 11, 1999 at Antelope Park.

# 4) PUBLIC HEARINGS:

- A. County Special Permit 170, Hilltop Estates Community Unit Plan, requested by Brian Carstens on behalf of Bill Carlson, for eight dwelling units, on property located at South 82<sup>nd</sup> Street and Pella Road in Lancaster County, Nebraska. (19992148)
- B. County Preliminary Plat 99018, Hilltop Estates, requested by Brian Carstens on behalf of Bill Carlson, for eight lots and one outlot, on property located at South 82<sup>nd</sup> Street and Pella Road in Lancaster County, Nebraska. (19992149)

The Chair opened the public hearing and asked if anyone wished to testify in favor of either the Special Permit or Preliminary Plat.

The Clerk administered the oath to Brian Carstens.

Brian Carstens appeared on behalf of Bill Carlson and stated that the community unit plan (CUP) is allowed under the Agriculture (AG) zoning district. He noted that part of the CUP is under the Village of Firth jurisdiction and their subdivision regulations have been met by agreeing to eight, three and one-half acre lots. To the east are the existing Burlington Northern Railroad tracks.

In response to a question asked by Workman, Carstens stated a geotechnical report was completed which indicated that the ground was suitable because of the compaction done at the time of the fill.

Mike DeKalb, Planning Department, requested that a letter and photographs from Darrell TeSelle be submitted into the record (Exhibit A). He summarized the letter by stating that Mr. TeSelle feels he has had water problems in his basement due to dirt work by the railroad and also well water odor.

Campbell stated in a telephone conversation with Mr. TeSelle, he asked for the opportunity to speak to Vincent Dreeszen, groundwater consultant, regarding his concerns.

She stated that the applicant, Bill Carlson, and Brian Carstens, developer, have agreed to leave the public hearing open for one week to allow Darrell TeSelle the opportunity to speak with Vincent Dreeszen.

The Chair recessed the public hearing until Tuesday, November 16, 1999.
