MOTION: Hudkins moved and Steinman seconded approval of the minutes of the Board of Equalization dated February 29, 2000. Campbell, Hudkins and Steinman voted aye. Workman abstained. Motion carried.

2) ADDITIONS AND DEDUCTIONS:

Approval of 18 additions and deductions to the tax assessment rolls per Exhibit "A".

MOTION: Steinman moved and Workman seconded approval. Campbell, Steinman, Hudkins and Workman voted aye. Motion carried.

3) **DISAPPROVAL OF A MOTOR VEHICLE TAX EXEMPTION:**

Nebraska Annual Conference of the United Methodist Church

MOTION: Steinman moved and Hudkins seconded denial of a motor vehicle tax exemption for Nebraska Annual Conference of the United Methodist Church because the application was not timely filed (more than 30 days from the date of purchase). Steinman, Workman, Campbell and Hudkins voted aye. Motion carried.

By direction of the Chair, a public hearing was set for Tuesday, March 21, 2000 at 2:30 p.m. in the County Commissioners Chambers, Room 112, on the first floor of the County-City Building for notice of valuation change for omitted or undervalued property for Scott Eugene Kreifels, et al.

The Chair recessed the Board of Equalization meeting until 2:30 p.m. when it was reconvened.

5) 2000 DISAPPROVED 451 TAX EXEMPTIONS ON REAL AND PERSONAL PROPERTY PER EXHIBIT "B":

Capitol City Christian Church

Rusty Miller, representing Capitol City Christian Church, appeared and explained that the properties were vacated for the purpose of beginning a new program to provide housing on a short term basis to individuals/families in crisis, along with educational and financial assistance from the church. He stated they would not be charging rent, however, individuals will pay for utilities and must complete a course with the church's finance ministry team.

In response to a question asked by Workman, Miller responded that they have charged rent in the past.

In response to a question asked by Campbell, Miller stated that the houses could be torn down for future expansion.

Norm Agena, County Assessor, recommended denial and stated that the predominant use of the houses is not for religious purposes.

Campbell asked Miller if a person has to be a member of the congregation in order to use the homes.

Miller responded he would be uncomfortable making that statement and that he wasn't sure if that would be the case.

In response to a question asked by Campbell, Miller stated that the goal is to meet the financial needs of families in crisis.

Harvest Community Church

Norm Agena, County Assessor, stated he couldn't find any documentation showing that the church exists under the address listed on the exemption. He stated the exemption form indicates that there is a van owned by the church, however, no motor vehicle title can be located.

Agena asked if the musical equipment could only be used to play in the church.

Brad White, representing Harvest Community Church, appeared and stated they meet once a week at Hill Elementary School. All of the musical equipment, he noted, is carried into the school and back out of the school on a weekly basis and the van is used to transport the equipment.

The Assessor requested White to provide a copy of the Articles of Incorporation for the church and suggested the item be deferred one week to obtain the additional information.

Liberty Gospel Fellowship Church

Pastor John Carter appeared on behalf of Liberty Gospel Fellowship Church and stated the property consists of two single family dwellings which are located west of the church. The church originally purchased the lots in order to build a new facility. He stated they are currently in the process of expanding the church.

He explained one of the homes is occupied and the individual currently pays \$425 rent per month. The other home is occupied by a family and they also pay approximately \$425 rent per month.

Pastor Carter stated when their plans are approved by the City the homes would be demolished for the expansion of their church. He stated they would be meeting with the architect on Friday and plans will be submitted to the City, with projected demolition being in April.

The County Assessor stated once they have begun the process and the building permits have been obtained the church may reapply for tax exemption up to August 1st.

Lincoln Church of Christ

Duane Burham, representing Lincoln Church of Christ, appeared and gave a brief background on the property stating that it was purchased with the intent of expanding the parking lot, however, it was used for approximately four to five years as a residence for a maintenance person. He added that no rent was charged. He stated there is currently a young family living in the home and that the husband performs odd jobs around the facility in exchange for living in the residence rent free.

Burham stated he feels they meet the criteria as outlined in Nebraska Department of Property Assessment and Tax Regulation 40-005.

Steinman asked if it is a condition that the individual(s) living in the residence perform custodial work for the church.

Burham stated they request that the individual(s) do what they can to maintain the house.

St. David's Episcopal Church

Gene Woodhead, representing St. David's Episcopal Church, appeared and stated the church burnt down last Easter and that they are trying to rebuild.

In response to a question asked by Hudkins, Woodhead stated the property hasn't been used for any religious activity during the past year.

Woodhead stated they have discussed having an open air morning service in the summer, however, due to the uncertainty of the weather they have decided against it.

Jim Shadley, representing the Planning Committee for St. David's Episcopal Church, appeared and stated they hoped to reapply for tax exemption by August 1st.

Woodhead added that there is a storage shed which contains stained glass windows and church related items.

Hudkins stated he felt that portion should be eligible for exemption.

Norm Agena, County Assessor, stated it would be storage, which is an incidental use, and recommended denial.

- **MOTION:** Hudkins moved and Steinman seconded to accept the Assessor's recommendation and deny the 451 tax exemption on real property for Bethel Baptist Church of Lincoln. Steinman, Hudkins, Workman and Campbell voted aye. Motion carried.
- **MOTION:** Steinman moved and Workman seconded to accept the Assessor's recommendation and deny the 451 tax exemption(s) on real or personal property for Christ's Place Church, Gentle Shepherd Baptist Church, Instructional Materials Council, Liberty Gospel Fellowship Church (2 exemptions), Lincoln Habitat for Humanity, Malcolm United Methodist Church (2 exemptions) and St. Matthews Episcopal Church. Workman, Campbell, Hudkins and Steinman voted aye. Motion carried.
- **MOTION:** Steinman moved and Hudkins seconded to defer action for one week in relation to a 451 tax exemption on personal property for Harvest Community Church. Hudkins, Workman, Campbell and Steinman voted aye. Motion carried.
- **MOTION:** Workman moved and Hudkins seconded to approve a 451 tax exemption on real property for Capitol City Christian Church.

Campbell suggested deferring action on Capitol City Christian Church and Lincoln Church of Christ to allow for further review on the issue regarding low income housing.

The maker of the motion withdrew the motion and the seconder agreed.

- **MOTION:** Workman moved and Steinman seconded to defer action for one week on tax exemption(s) for Capitol City Christian Church (2 exemptions) and Lincoln Church of Christ. Campbell, Steinman, Workman and Hudkins voted aye. Motion carried.
- **MOTION:** Steinman moved and Hudkins seconded to accept the Assessor's recommendation and deny the 451 tax exemption on real property for St. David's Episcopal Church.

Hudkins stated he seconded the motion for discussion purposes. He explained that he believes the church continues to have property used for storing artifacts belonging to the church and that he would not support the motion.

ROLL CALL: Campbell and Steinman voted yes. Hudkins and Workman voted no. Motion tied.

Campbell stated the item would be deferred until Tuesday, March 28, 2000 at 2:30 p.m.

The Chair opened the public hearing and asked if anyone wished to provide testimony.

Campbell noted that there has been one letter protesting the renewal of Star City Hockey L.L.C.

The Clerk administered the oath to Richard Halvorsen.

Richard Halvorsen, 6311 Inverness Road, appeared and addressed his concern regarding the renewal of a liquor license for Star City Hockey L.L.C. He referred to Nebraska Revised Statute 53-177 which states that the sale of retail alcoholic liquor cannot be within 150 feet of any church, school, hospital or home for aged or indigent persons or for veterans, their wives or children. Halvorsen stated there is currently a school located in the Expo Building and the site will continue to be a temporary location for schools in the future. He said he felt that renewal of the license would be in violation of the statute.

Dave Johnson, Deputy County Attorney, indicated that the statute "shall not apply to any location within such distance of one hundred and fifty feet for which a license to sell alcoholic liquors at retail has been granted by the Nebraska Liquor Control Commission for two years continuously prior to making of application for license". He also stated he thought that Star City Hockey had requested renewal for the prior two years preceding 2000.

Halvorsen stated he believed the two years would expire April, 2000.

Campbell suggested that the automatic renewal for Star City Hockey be held one week to allow for review of the records in relation to the year of issuance.

The Chair asked if anyone else wished to provide testimony.

No one appeared and the hearing was closed.
