Tim Genuchi, County Clerk's Office, submitted documentation regarding a ten, five and one year comparison in trends (Exhibit A) and a copy of the tax rates for Lancaster County for fiscal year 2000-2001 (Exhibit B). He noted that rates submitted were final and included the new bonds for Norris and Waverly.

Campbell stated the rate increased by 2.31 percent over last year, however, over a five year period the rate decreased by 16.59 percent. The ten year period decreased by 18.52 percent.

1) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, October 3, 2000. (A copy of these minutes is on file in the Office of the Lancaster County Clerk.)

- **MOTION:** Hudkins moved and Heier seconded approval of the minutes of the Board of Commissioners meeting dated October 3, 2000. Campbell, Hudkins, Heier and Steinman voted aye. Motion carried.
- 2) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, October 10, 2000.
 - **MOTION:** Heier moved and Steinman seconded approval. Heier, Campbell, Steinman and Hudkins voted aye. Motion carried.

3) **PUBLIC HEARINGS:**

A. Continuation of a public hearing regarding Comprehensive Plan Amendment 94-45, requested by the Director of Planning, to incorporate by reference the "Greater Arnold Heights Area Neighborhood Plan" and to amend the Lincoln Land Use Plan accordingly.

The Chair reconvened the public hearing.

3) **PUBLIC HEARINGS CONTINUED:**

John Wood, Executive Director of the Lincoln Airport Authority, appeared and urged the County Board to adopt the Comprehensive Plan Amendment as amended by the City Council.

Steinman asked if discussion took place regarding the concern of the Health Department regarding the buffer between the residential and industrial zoned areas.

Steve Henrichsen, Planning Department, stated that the compromise was supported by the Planning Department and met some of the concerns which were raised by the Health Department. He noted the area is approximately 600 feet wide between Mathis and West Adams Street. The area closest to the neighborhood would be an open space buffer and the remaining portion would be industrial. Henrichsen said the area south of West Adams Street, near Sun-Husker Foods, has a separate Comprehensive Plan Amendment which will be proceeding through the process. He explained that the 135 acres is owned by the Chamber of Commerce and that they are in the process of selling the property. Henrichsen stated the amendment will be before the Planning Commission on October 18, 2000.

In response to a question asked by Steinman, Henrichsen said the version which the City Council adopted on October 2, 2000 did not show commercial property north of West Adams Street. The open space buffer was continued along the east side.

Wood stated that the Lincoln Airport Authority would not object to the proposal.

Beverly Fleming, appeared on behalf of the Lincoln Housing Authority, and stated that the Lincoln Housing Authority supports the project.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

MOTION: Steinman moved and Heier seconded approval of Comprehensive Plan Amendment 94-45 as amended by the City Council and directed the County Attorney's office to prepare a resolution to be adopted on October 17, 2000. Steinman, Heier, Campbell and Hudkins voted aye. Motion carried.

3) **PUBLIC HEARINGS CONTINUED:**

B. County Change of Zone 202, requested by the Director of Planning, to amend Article 2 and Article 9 of the Lancaster County Zoning Resolution to define and allow sexually oriented live entertainment establishments as a permitted special use in the "I" Industrial district.

The Chair opened the public hearing.

Kathleen Sellman, Planning Director, noted that the studies referenced in the analysis of the Planning staff report, numbers four, five and six, should be incorporated, by reference, into the official file.

Three elements were noted by Sellman:

- Addition of three definitions:
 - 1. Sexually oriented live entertainment establishment(s)
 - 2. Specific anatomical areas.
 - 3. Specific sexual activities.
- Addition to the "I" Industrial district, a listing under unclassified industries and uses (Section 9.003) for sexually oriented live entertainment establishment
- Addition to Section 13.015 establishing standards for locating sexually oriented live entertainment establishments through the "Permitted Special Use" process which provides for a Planning Commission hearing, with a final decision by the Lancaster County Board prior to the operation of a sexually oriented live entertainment establishment within the County. The "Permitted Special Use" standards include that the establishment must meet all federal, state and local standards; the establishment must be located in an "I" Industrial zoned district; there must be a minimum separation distance of 1,500 feet between any two such uses; there must be a minimum separation distance of 1,000 feet between such use and from specific uses including all residential uses, churches, public and private schools, childhood care facilities, parks, hospitals, libraries, etcetera. The method of measurement would be from nearest door to nearest door.

The Chair asked if anyone else wished to provide testimony.

Dave Johnson, Deputy County Attorney, requested that documentation demonstrating how the proposed changes would be reflected in the zoning regulations be submitted into the record (Exhibit C).

No one else appeared and the Chair closed the public hearing.

3) **PUBLIC HEARINGS CONTINUED:**

MOTION: Steinman moved and Heier seconded approval of County Change of Zone 202 and directed the County Attorney's office to prepare a resolution to be adopted on October 17, 2000. Hudkins, Campbell, Steinman and Heier voted aye. Motion carried.

C. Amend County Board Resolution #2832 Regulating Individual Sewage-Disposal Systems. The amendment would change the fees as provided in the proposed resolution.

The Chair opened the public hearing.

Scott Holmes, Health Department, appeared and explained that due to an increase in home building in the County and within the three-mile zoning jurisdiction they are in need of additional staffing. He stated the additional staff was approved in the budget as were the fees to assist in supporting the additional staffing.

The fee, Holmes stated, would increase to \$200 for a sewage system permit application and installation cost. He noted that their sewage program is approximately 50 percent fee funded. With the increase it would be approximately 60 percent fee funded.

Kerry Eagan, Chief Administrative Officer, stated that the fees have always been collected by the Health Department and are credited to the budget.

Eagan also noted that the City would have jurisdiction within the three-mile zoning jurisdiction.

The Chair asked if anyone else wished to testify regarding the amendment.

No one appeared and the public hearing was closed.

MOTION: Steinman moved and Heier seconded approval of the amendment and directed the County Attorney's Office to prepare a resolution to be adopted on October 17, 2000. Hudkins, Steinman, Heier and Campbell voted aye. Motion carried.
