The Board of Commissioners meeting was called to order at 1:30 p.m.

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, January 7, 2003.

**MOTION:** Hudkins moved and Stevens seconded approval of the minutes of the

#### 2) **SPECIAL PRESENTATIONS**:

- A. Commissioners Ray Stevens, Deb Schorr and Bob Workman were given special recognition for their participation in the candidate forum sponsored by the Mental Health Voter Empowerment Project.
- B. Appointment of S. June Remington as the Director of the Lincoln Area Agency on Aging, effective January 21, 2003, at a salary of \$57,000.

A. Election of Chair and Vice Chair for the Lancaster County Board of Commissioners for 2003.

MOTION: Hudkins moved and Stevens seconded to nominate Bernie Heier as Chair of the Lancaster County Board of Commissioners. Workman, Hudkins, Schorr and Stevens voted aye. Heier abstained from voting. Motion carried.

Heier assumed direction of the meeting.

**MOTION:** Workman moved and Schorr seconded to nominate Ray Stevens as Vice Chair of the Lancaster County Board of Commissioners. Schorr, Workman, Heier and Hudkins voted aye. Stevens abstained from voting. Motion carried.

- B. Applications for two special events permits from the Lincoln Track Club to hold the following events:
  - 1. State Farm "Run For Your Life" road race on Saturday, March 29, 2003 beginning at 9 a.m.
  - 2. Havelock Run on Saturday, May 17, 2003, beginning at 8 a.m.

Larry Worth, President of the Lincoln Track Club, was present to answer questions.

- MOTION: Workman moved and Stevens seconded approval of two special events permit applications from the Lincoln Track Club to hold the State Farm "Run For Your Life" road race and the Havelock Run. Stevens, Hudkins, Heier, Workman and Schorr voted aye. Motion carried.
- C. A utility relocation agreement with Norris Public Power District of Beatrice for adjustment of some or all of its facility as it relates to County Project No. C55-P-401(1) on Saltillo Road from South 84<sup>th</sup> Street to South 98<sup>th</sup> Street. The County shall pay up to \$25,000. (C-03-0022)
- MOTION: Workman moved and Stevens seconded approval of a utility relocation agreement with Norris Public Power District of Beatrice for adjustment of some or all of its facility as it relates to County Project No. C55-P-401(1) on Saltillo Road from South 84<sup>th</sup> Street to South 98<sup>th</sup> Street. Workman, Schorr, Hudkins, Stevens and Heier voted aye. Motion carried.
- D. Grant contract with Heartland Big Brothers/Big Sisters to provide mentors for 20 identified high-risk youth in grades K-6. The Grantee has established a program for the purpose of the County Juvenile Aid Program. The County shall grant \$3,000 for the services. The term of the agreement is from November 1, 2002 to January 31, 2003. (C-03-0023)
- MOTION: Hudkins moved and Workman seconded approval of a grant contract with Heartland Big Brothers/Big Sisters to provide mentors for 20 identified high-risk youth in grades K-6. The grantee has established a program for the purpose of the County Juvenile Aid Program. Hudkins, Workman, Heier, Schorr and Stevens voted aye. Motion carried.

E. Grant contract with Catholic Social Services to provide cultural and employment orientation to refugees and place 100 participants into employment within 4 to 60 months. The County shall make a grant in the amount of \$183,810. These funds were received from the Federal Targeted Assistance Grant. The term of the agreement is from October 1, 2002 to September 30, 2003. (C-03-0024)

MOTION: Schorr moved and Hudkins seconded approval of a grant contract with Catholic Social Services to provide cultural and employment orientation to refugees and place 100 participants into employment within 4 to 60 months. Schorr, Heier, Stevens, Workman and Hudkins voted aye. Motion carried.

F. Contract amendment to an agreement with Lisa Young for the provision of nurse practitioner services which was executed on July 9, 2002, under County Contract No. C-02-303. The amendment provides for up to eighteen (18) hours per week of services rather than twelve (12). The amendment also requires the Contractor to provide the County with a current Certificate of Insurance. All other terms and conditions shall remain in full force and effect. (C-03-0030)

MOTION: Workman moved and Hudkins seconded approval of a contract amendment to an agreement with Lisa Young for the provision of nurse practitioner services which was executed on July 9, 2002, under County Contract No. C-02-303. Hudkins, Schorr, Stevens, Heier and Workman voted aye. Motion carried.

H. Approval of the Noxious Weed Control Plan for Lancaster County for the year 2003.

Russ Shultz, Noxious Weed Control Superintendent, gave a brief overview of the weed control plan for 2003.

**MOTION:** Workman moved and Stevens seconded approval of the 2003 Noxious Weed Control Plan for Lancaster County. Heier, Schorr, Stevens, Hudkins and Workman voted aye. Motion carried.

I. Political subdivision tort claim filed by Mark Geist for damages to his vehicle in the amount of \$2,926.11, plus rental car costs.

Mark Geist, 8800 Pella Road, appeared and gave a brief summary regarding the claim. He stated it was his opinion that the maintainer operator should have seen the concrete object along the side of the road.

Geist also submitted a copy of a letter from Patti Clark, 8770 Pella Road, indicating that the object had been on the side of the road for two to three weeks prior to the incident.

David Johnson, Deputy County Attorney, requested that the letter from Mrs. Clark be submitted into the record (Exhibit 1).

Johnson introduced David Sedlacek, claims supervisor for Continental Western Group, who gave an overview of the process used in reviewing the claim.

Sedlacek stated it is their opinion that Ms. Geist assumed an unreasonable risk by straddling the gravel and that based on the evidence which was presented to them, they believe that there is enough of a question which would suggest that Ms. Geist's negligence is at least equal to, if not greater than, the operator of the maintainer.

Cook suggested there be ten staff to operate the facility at a cost of approximately \$236,000 per year. With benefits included the cost would increase to approximately \$306,860.

Cook further stated there would be an approximate cost of \$510 per client/per month if 50 individuals were placed in the program as compared to \$1,800 per inmate/per month in the jail.

The initial start-up cost, Cook stated, for April, 2003 through June, 2003 would be approximately \$78,000.

Cook also stated he would like to seek an opinion from the Attorney General regarding a moratorium on individuals sitting in jail for fines.

In response to a question asked by Workman, Dave Kroeker, Budget and Fiscal Officer, stated they have \$250,000 for start-up costs.

**MOTION:** Workman moved and Stevens seconded to approve program plan relating to Alternatives to Incarceration, using the 9<sup>th</sup> and J Street location. Workman, Hudkins, Schorr, Stevens and Heier voted aye. Motion carried.
