The Board of Commissioners meeting was called to order at 1:30 p.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, September 16, 2003.

There was no public comment and the meeting proceeded as planned.

Denial was also recommended by the County Attorney's Office.
