The Board of Commissioners meeting was called to order at 2:30 p.m..

The Chair reconvened the public hearing and asked if anyone wished to provide additional testimony.

No one appeard.

She stated, if approved, it would be the first time that the County Board would allow beer to be sold by the glass/cup in a convenience store setting anywhere in the County. Schorr stated she would like additional discussion next week when the full Board would be present.
