The Board of Commissioners meeting was called to order at 1:30 p.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, March 9, 2004.

MOTION: Hudkins moved and Workman seconded approval of the minutes of

the Board of Commissioners meeting dated March 9, 2004. Schorr,

Hudkins, Workman and Stevens voted aye. Motion carried.

2) SPECIAL PRESENTATIONS:

A. A resolution recognizing Saturday, March 20, 2004 as Central Plains Severe Weather Symposium and Storm Spotter Appreciation Day -Doug Ahlberg, Emergency Management Director (R-04-0024)

Doug Ahlberg, Emergency Management Director, appeared and gave a brief overview of Central Plains Severe Weather Symposium and Storm Spotter Appreciation Day on March 20, 2004. He stated the symposium was being held at North Star High School in conjunction with the annual spotters training for severe weather.

2) **SPECIAL PRESENTATIONS CONTINUED:**

3) PUBLIC COMMENT:

Kristy Mundt, Deputy County Attorney, appeared and explained that an emergency item regarding the temporary closure of a bridge (N114) needed to be added to the agenda.

Don Thomas, County Engineer, explained that the bridge is located south of Denton on a dead-end road and is used by two landowners, as well as the Village of Denton to access their well. He explained that over time the abutments have begun to wash out causing the bridge to lean and also causing the wiring used to power the well to separate.

No one appeared and the hearing was closed.

Terry Wagner, Sheriff, appeared and explained that it is a violation when someone charges admission to enter onto their property and then serves alcohol free of charge. He stated he felt that it is possible the charge for the room may constitute charging for the wine.

Dean Settle, Community Mental Health Center Director, and Jim Baird, Cornhusker Place Director, appeared and gave a brief overview regarding the agreement.

Workman, Schorr, Hudkins and Stevens voted aye. Motion carried.

B. Conservation easement agreement between the City of Lincoln, Lancaster County and Eugene and Jeanette M. Theer for property generally located along Salt Creek from Wilderness Park to one-half mile south of Martell Road in Lancaster County, Nebraska, consisting of 39.71 acres. The property is located within the 100-year floodplain as designated by the Federal Emergency Management Agency (FEMA). The City and County will jointly contribute \$36,500 for the easement conveyance. (C-04-0140)

Nicole Fleck-Tooze, Public Works and Utilities, appeared and explained the conservation easements (Items 6B through 6E) are being acquired through the Hazard Mitigation Grant Program. Seventy-five percent of the funding for the program was received from the Federal Emergency Management Agency (FEMA), with the 25 percent local match being split between the City of Lincoln and the County. Fleck-Tooze added that the agreements are for properties located between Saltillo and Bennet Roads in the Salt Creek floodplain.

In response to a question asked by Hudkins, Mike DeKalb, Planning Department, stated that a conservation easement would not restrict the total density of the area or the ability for development other than within the constraints of the easement itself.

The estimated cost of this service is \$1,020, however, Midland Recycling does not charge for the recycling services and the total annual revenue for recyclables for all three governmental entities is estimated at over \$5,600.
