The Board of Commissioners meeting was called to order at 1:30 p.m..

Mr. McKay informed the Board that the application was for the concessions for the marina at Pawnee Lake.

Workman asked the applicants if they had taken a responsible hospitality class.

Mrs. McKay stated she has been in the food and beverage business for 25 years and had previously taken a class, however, they would not object to taking the class again.

In response to a question asked by Schorr, Mrs. McKay stated prior to living in Lincoln, she had worked for Clarion Hotels and Holiday Inn in the food and beverage area.

Hudkins asked the McKays when they would be opening the restaurant.

Mrs. McKay indicated they would like to open by May 1st.

- A triathlon on Sunday, July 18, 2004, beginning at 7:30 a.m. at Branched Oak Lake. The race will begin at Liebers Point on the west side of Branched Oak Lake, with the cycling portion heading west on Branched Oak Road and circling the lake.

Mlnarik stated July 10th through July 18th they would be celebrating 20 years of the Cornhusker State Games.

She stated they anticipate they will be able to find a solution which will either lower the cost or an alternative way to provide transportation.

Peck stated she attended a national conference last week and came back with some ideas and resources.
