The Board of Commissioners meeting was called to order at 1:30 p.m..

A moment of silence was observed in memory of Elaine Focken, Hallam, Nebraska and in honor of all those who sustained losses with regard to the tornado on May 22, 2004.

Terry Wagner, County Sheriff, gave an overview of his office's response to the calls for service with regard to the storm. He reported that the Sheriff's Office is utilizing their Emergency Mobilization Plan in which a portion of their personnel are placed on 12 hour work days, with no days off and added that there are currently three points of emphasis:

- Sheriff's deputies are providing security in the Village of Hallam
- State Patrol is providing perimeter security for the Village of Hallam
- Sheriff's deputies are patrolling the entire swath of the tornado Hallam,
 Bennet, Norris High School, Panama and Holland

Wagner added that there is a curfew in Hallam from 8 p.m. to 8 a.m. and that they would maintain security in Hallam until they feel it is no longer needed.

Mike Merwick, Building and Safety Director, gave a brief overview of documentation regarding post-disaster red flag, choosing a builder/remodeler and building permits (Exhibit 1) which will be available for those who have suffered damage or destruction of their homes. He added that staff from the Building and Safety Department would be available from 12 p.m. to 7 p.m. at the Hickman Town Hall on Tuesdays and Fridays beginning June 1, 2004. Merwick explained that staff would be able to issue building permits, special permits for temporary housing and answer questions.

Doug Ahlberg, Emergency Management Director, gave a brief overview regarding the recent storm activity and indicated they had begun the process of registering volunteers. 350 volunteers were sent to the Village of Hallam and 100 volunteers were sent to Holland and the area south of Holland to check various farmsteads and acreages which were affected by the storm. He reported that Norris High School was not ready to accept volunteers at the present time. Ahlberg also discussed household waste/hazardous materials, debris management and disposal site for materials which cannot be burned and burn permits.

4) PUBLIC HEARINGS CONTINUED:

Public hearing Items 4A and 4B were heard together.

The Vice Chair opened the public hearings.

The oath was administered to Brian Carstens.

Carstens appeared on behalf of Harlan and Judith Stiefel and gave a brief explanation regarding the Special Permit and Preliminary Plat. He stated the proposal would include private septic, private wells and private roadways.

Heier referred to a recommendation from the Planning staff regarding build-through standards and stated the County Board, to his knowledge, has never inferred that there would be any deferrals regarding build-throughs. He stated the County Board would continue to consider all applications.

The Vice Chair asked if anyone else wished to testify.

No one appeared and the hearings were closed.

C. County Special Permit 04012, requested by Douglas Rogers on behalf of U.S. Cellular Wireless Communications, for authority to construct a 225 foot broadcast tower capable of accommodating at least five carriers, with a request to waive the fall zone, on property generally located northeast of the intersection of South 148th Street and Highway 2, Lancaster County, Nebraska. (See New Business Item 5C for resolution.)

The Vice Chair opened the public hearing and noted a correction regarding the height of the tower. He stated it should be 255 feet instead of 225 feet.

The Clerk administered the oath to Doug Rogers, appearing on behalf of U.S. Cellular.

Rogers gave a brief overview regarding the proposal.

In response to a question asked by Workman, Rogers referred to a memorandum from Brian Will, Planning Department, relating to a cost comparison between a self-supporting lattice tower and a monopole (Exhibit 2).

Brian Will, Planning Department, indicated waiver of the fall zone would only affect the field access to the property and would not affect any public roadway.

Workman asked if there was any provision for Emergency Services being a colocater.

The oath was administered to David Kepp, representing U.S. Cellular at 1020 Leavenworth Street, Suite 433, Omaha, Nebraska.

Kepp indicated he would agree to a condition of approval that the County be allowed to install emergency facilities on U.S. Cellular's tower.

Workman asked if it would be at no charge to the County.

Kepp responded it would be at no charge.

The Vice Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

Agena stated if the daycare operator receives the 501-C3 status by August 1, 2004, then she may reapply for the exemption.

Nebraska District of the Lutheran Church Missouri Synod

John Hertzler, appeared on behalf of Nebraska District of the Lutheran Church Missouri Synod and explained they feel they are qualified for a full exemption rather than a partial. He stated it is felt that the caretaker's apartment has both religious and educational use. Hertzler stated the apartment is part of a program where students interested and involved in the ministry of the chapel are housed during part of their education at the University. The two criteria for living in the apartment are that the individual(s) must be a student and must be involved in the ministry. Hertzler stated the students lead Bible studies and fellowship activities with other students and often open their apartment up for activities such as Bible studies and interpersonal communication with other students. He stated the

students are considered a part of the chapel staff and attend staff meetings.

Workman asked if rent was charged for the apartment.

Hertzler responded no.

Scott Gaines, Chief Administrative Deputy for the County Assessor/Register of Deeds Office, stated the issue is whether the use of the space, as an apartment, is predominantly an educational use or a religious use. He stated, historically, it has been the contention of the Assessor/Register of Deeds Office that its primary use is for an apartment.
