Warren Cook, with Warren F. Cook and Associates, gave an overview of documentation disseminated entitled *Alternatives to Incarceration Program* (Exhibit 1).

Dave Kroeker, Budget and Fiscal Director, explained the increase of appropriations was due to higher utility costs at the Juvenile Detention Facility and at the Community Mental Health Center.

David Lucas, bond counsel, appeared and gave a brief explanation regarding the amendment.

E. An agreement with the Asian Community and Cultural Center for care coordination services using the wraparound process for youth, ages 10 to 18, who have severe emotional disorders and who are at risk of becoming involved in the juvenile justice system. The Asian Community and Cultural Center will provide one full-time Care Coordinator. Term of the agreement is July 1, 2004 through June 30, 2005. The County will pay up to \$46,695.60 for the services. (C-04-0250)

MOTION: Schorr moved and Stevens seconded approval of an agreement with the Asian Community and Cultural Center for care coordination services using the wraparound process for youth, ages 10 to 18, who have severe emotional disorders and who are at risk of becoming involved in the juvenile justice system. Workman, Schorr, Heier and Stevens voted aye. Motion carried.

F. An agreement with the Indian Center for care coordination services using the wraparound process for youth, ages 10 to 18, who have severe emotional disorders and who are at risk of becoming involved in the juvenile justice system. The Indian Center will provide one full-time Care Coordinator. Term of the agreement is July 1, 2004 through June 30, 2005. The County will pay up to \$44,009.10 for the services. (C-04-0251)

An evaluation services contract with Lock P.C. d/b/a Orr Psychotherapy Resources for evaluation services in a residential or non-residential setting for youth as ordered by the Separate Juvenile Court of Lancaster County. Term of the agreement is July 1, 2004 to June 30, 2005. The County will pay \$884.22 for each basic evaluation. (C-04-0253)

I. A licensing agreement with Swank Motion Pictures, Inc. for showing video cassette movies at the Lancaster County Juvenile Detention Center. Term of the agreement is July 1, 2004 through June 30, 2005. The County will pay \$200 for the license. (C-04-0254)

The contractor has notified the County that additional mileage funds are needed and as a result, the parties wish to amend the compensation from \$216,558 to \$220,303. (C-04-0248)

MOTION: Workman moved and Schorr seconded approval of an amendment to an agreement with Cedars Youth Services, under County Contract C-04-0336, for behavioral health services to high need youth who are wards of the State residing in Lancaster County.
