The Board of Commissioners meeting was called to order at 1:30 p.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, July 6, 2004.

## 2) SPECIAL PRESENTATIONS:

A. An exceptional circumstance for Scott Waters, an employee with the Lancaster County Corrections Department, in the amount of \$500.

**MOTION:** Workman moved and Heier seconded approval of an exceptional

circumstance award to Scott Waters, an employee with the Lancaster County Corrections Department, in the amount of \$500. Workman, Schorr,

Heier, Hudkins and Stevens voted aye. Motion carried.

  - ► Install a "Caution Driveways Ahead" sign on South 82<sup>nd</sup> Street 800 feet north of Bennet Road for northbound traffic.
  - ► Install a "25 Mile Per Hour" speed limit sign in the Highlands subdivision on Braemar Road west of South 56<sup>th</sup> Street for westbound traffic.

- MOTION: Schorr moved and Hudkins seconded approval of an agreement with the University of Nebraska-Lincoln, Center for At-Risk Children's Services for the administration of evaluation tools required by the System of Care. Hudkins, Schorr, Heier, Workman and Stevens voted age. Motion carried.

Term of the agreement is July 1, 2004 through June 30, 2005. The County will pay \$40,883 for such services. (C-04-0317)

Schorr, Hudkins, Heier, Workman and Stevens voted age. Motion carried.

F. An agreement with Lisa Young for the services of a nurse practitioner to assist in the provision of psychiatric services at the Lancaster County Community Mental Health Center. Term of the agreement is July 1, 2004 through June 30, 2005. The County will pay \$55 per hour for no more than 16 hours per week. (C-04-0320)

MOTION: Hudkins moved and Heier seconded approval of an agreement with Lisa Young for the services of a nurse practitioner to assist in the provision of psychiatric services at the Lancaster County Community Mental Health Center. Workman, Schorr, Heier, Hudkins and Stevens voted aye. Motion carried.

G. An agreement with Lincoln Psychological Services, P.C. for mental health services, through Daniel Leggiadro, at the Community Mental Health Center. Term of the agreement is July 1, 2004 through June 30, 2005. The County will pay \$65 per hour for no more than 45 hours per week. The County will also pay \$100 per weekend where Dr. Leggiadro has agreed to provide on-call services. (C-04-0321)

MOTION: Heier moved and Hudkins seconded approval of an agreement with Lincoln Psychological Services, P.C. for mental health services, through Daniel Leggiadro, at the Community Mental Health Center. Heier, Workman, Hudkins, Schorr and Stevens voted aye. Motion carried.

H. An amendment to an agreement with BryanLGH Medical Center, under County Contract C-03-0351, for nursing services for the Lancaster County Community Mental Health Center. BryanLGH has notified the County that the hourly rate for nursing services has increased from \$41.84 per hour to \$45.35 per hour, effective July 1, 2004, and as a result, the parties wish to amend the agreement to reflect such change. (C-04-00319)

I. An amendment to an interlocal agreement with the State of Nebraska, Probation Administration under County Contract C-03-0318, to facilitate the administration of the Drug Treatment Court for the Lancaster County District Court. The federal grant to fund Drug Court expires on August 31, 2004, and as a result, the parties wish to extend the term of the agreement from June 30, 2004 to August 31, 2004. The parties further wish to amend the agreement to provide for compensation for the two month extension period. (C-04-0322)

MOTION: Heier moved and Stevens seconded approval of an amendment to an interlocal agreement with the State of Nebraska, Probation Administration under County Contract C-03-0318, to facilitate the administration of the Drug Treatment Court for the Lancaster County District Court.

J. Acceptance of a grant award from the Nebraska Commission on Law Enforcement and Criminal Justice for Project "A Coordinated Response to Reducing Domestic Violence in Lancaster County". The County will receive \$270,667 of which \$67,667 is the County's match share. Term of the grant award is July 1, 2004 to June 30, 2005. (C-04-0318)

MOTION: Schorr moved and Hudkins seconded to accept a grant award from the Nebraska Commission on Law Enforcement and Criminal Justice for Project "A Coordinated Response to Reducing Domestic Violence in Lancaster County".

Heier noted a 12.5 percent increase in mental health services for the current year.

Schorr referred to Legislative Bill 1083 and stated it is imperative that the County Board continue to make their needs and concerns known to the Governor and to speak in support of reimbursement for expenses as a part of mental health reform.

Heier stated some services are not mandatory by county government, however, they are offered because of the need for the citizens in Lancaster County.
