The length of the agreement is from the date of execution until the cost report has been submitted to the County. The County will pay \$3,700 to \$4,100 for the services. (C-05-0240)
- C. An interlocal agreement between Lancaster County and the City of Hickman for law enforcement services through the Lancaster County Sheriff's Office. The County will assign one deputy for law enforcement purposes in the City of Hickman. The County will be paid \$6,343 per month for the services of the deputy. Term of the agreement is September 1, 2005 to August 31, 2006. (C-05-0239)
- D. An interlocal agreement with the City of Hickman for law enforcement services within the City, as needed by the City. The Sheriff will assign one deputy for duty and provide one Sheriff's cruiser. Term of the agreement is from November 1, 2005 to October 31, 2006. The County will be reimbursed at the deputy's overtime rate for the services provided and will be reimbursed 40.5 cents per mile for cruiser maintenance. (C-05-0241)
- E. A Federal Equitable Sharing agreement between the Federal Government and the Lancaster County Sheriff's Office for participation in the equitable sharing program and restrictions upon the use of federally forfeited cash, property, proceeds and any interest earned.
