5) **OLD BUSINESS:**

- A. Comprehensive Plan Amendment 05012, by the Director of Planning at the request of Prairie Homes, to amend the 2025 Lincoln/Lancaster County Comprehensive Plan to change the land use from Urban Residential to Commercial and to change the commercial size designation from Neighborhood Center to Community Center, on land generally located at North 84th and Adams Streets.

6) **NEW BUSINESS:**

- A. A resolution in the matter of County Special Permit 05025, requested by Roger and Lynn Engelbart, for authority to reside in a mobile home as a temporary residence while building a permanent residence on property generally located at Northwest 112th Street and West Fletcher Road (11255 West Fletcher Road) in Lancaster County, Nebraska. (R-05-0074)
- B. A resolution in the matter of County Change of Zone 05032 requested by Valerie Harris, from AG Agricultural to AGR Agricultural Residential, on property generally located at the southeast corner of Southwest 56th Street and West Denton Road (7101 Southwest Hunters Circle, Denton, NE.) (R-05-0072)
- C. A resolution approving Comprehensive Plan Amendment 04010, requested by Apple's Way, L.L.C., to amend the 2025 Lincoln/Lancaster County Comprehensive Plan, to change the land use designation from Urban Residential to Commercial on property generally located at South 66th Street and Highway 2. (R-05-0071)
- D. A resolution authorizing the installation of a 40 mile per hour speed limit sign for eastbound traffic on West Sprague Road after the existing "Reduced Speed Ahead" sign and before the existing 25 mile per hour speed limit sign at the west village limit of Sprague. (R-05-0073)
- E. An application for a Special Designated License from K-SARA Enterprises, Inc. d/b/a Kevin Meier Imports to provide liquor beverage service in connection with a post race ceremony for 'Footstock' (10k road race) on Saturday, July 9, 2005 from 4 p.m. to 1 a.m. at South 121st and "A" Streets, Walton, Lancaster County, Nebraska.
- F. An affiliation agreement with the Board of Regents of the University of Nebraska, on behalf of the Clinical Psychology Training Program, for two graduate psychology students who will provide services such as psychotherapy, counseling and psychological testing for the Community Mental Health Center. Term of the agreement is June 1, 2005 to May 31, 2006. The County will pay \$29,354 for the services. (C-05-0327)

6) **NEW BUSINESS CONTINUED:**

- G. An interlocal agreement with the City of Lincoln, on behalf of the Lincoln-Lancaster County Health Department, for medical services at the Youth Services Center. Term of the agreement is July 1, 2005 to June 30, 2006. The County will pay based upon the following rates: a) a monthly fee of \$9,205 for registered nursing services and the availability of physician services, b) \$79.05 per physician's visit to the Detention Center, c) \$8.45 per telephone conversation with a physician, d) physical exam/assessment completed at actual cost, e) \$35 per dose of Hepatitis B vaccine for each employee, f) \$10 for tuberculosis testing of each employee, g) \$20 employment assessment for each employee and h) \$40 per hour for on-site laboratory services by a laboratory technician. Should the County Attorney's Office require conferences, meetings, or in-court testimony of nurses, it will be billed to the County at the rate of \$42.50 per hour, and should the County Attorney's Office require the same of physicians, it will be billed to the County at the rate of \$79.50 per hour. - H. An agreement with Great Plains Appraisal to provide referees to hear valuation protests and transmit to the Lancaster County Board of Equalization all papers relating to such protests, together with written findings and recommendations. Great Plains Appraisal will provide the services of Richard Keith, Wayne Kubert, Cay Lacey, Tom Kubert, Mickey Tuttle, Shana Sprackling, Ty Fleck, Cody Gerdes and Lori Johnson. The County will pay from \$25 per hour for clerical support to \$80 per hour for referees. (C-05-0330)

6) **NEW BUSINESS CONTINUED:**

- J. An agreement with Samaritan Counseling Center for after hours emergency mental health services through an emergency crisis line. The County, through the Community Mental Health Center, will provide services to clients of Samaritan Counseling Center when the Center is closed. The County will be paid \$50 per hour and calculated per quarter hour. Term of the agreement is January 1, 2005 to June 30, 2005. (C-05-0343)
- K. A system service agreement with General Fire & Safety Equipment Company of Lincoln to service the Kitchen Hood Fire Suppression System at the Community Mental Health Midtown Center, located at 2966 "O" Street. The County will pay \$65 for each semi-annual inspection. (C-05-0345)
- L. Amendment No. 1 to the network provider contract with the Regional Behavioral Health Authority (Region V), under County Contract C-04-0493, for the provision of certain mental health, alcoholism, substance abuse and related behavioral mental health services at the Community Mental Health Center. The amendment increases the amount that the County will be reimbursed from \$4,313,859 to \$4,351,665. (C-05-0329)
- M. A subscription plan amendment and appropriation of funds amendment between Lexis Nexis, the City of Lincoln and Lancaster County to reduce the number of users from 110 to 85. Such reduction is due to the Judges and their law clerks moving to the State Lexis contract. The new monthly rate per user will be \$30 with a three percent escalator per year. Term of the amendment is July 1, 2005 through June 30, 2008. (C-05-0344)
- N. Addendum No. 3 to an agreement with ARAMARK Correctional Services, Inc., under County Contract C-02-0454, for the management of the food service at the Lancaster County Corrections facility. The amendment increases the price per meal charged as a result of an increase in the Consumer Price Index (C.P.I.). The new prices will be effective on June 1, 2005 and remain firm through May 31, 2006. (C-05-0346)
- O. A political subdivision tort claim filed against Lancaster County by Roger P. Cox, on behalf of Henry L. Balters, in the amount of \$10,000.
- P. A political subdivision tort claim filed against the Lancaster County Corrections Department by Elizabeth Hogrefe for medical bills and "reimbursement" for days spent in jail.
