The Board of Commissioners meeting was called to order at 1:30 p.m..

1) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, January 4, 2005.

**MOTION:** Workman moved and Schorr seconded approval of the minutes of the Board of Commissioners meeting dated January 4, 2005. Schorr, Workman and Hudkins voted aye. Stevens abstained from voting.

### 2) PUBLIC COMMENT:

Gordon Chapelle, 4800 West Old Cheney Road, appeared and presented the County Board with a framed copy of a document, dated June 26, 1878, creating the Lancaster County Agricultural Society.

### 4) **PUBLIC HEARINGS**:

A. County Final Plat 04111, Finigan 2<sup>nd</sup> Addition, requested by Lyle Loth of ESP on behalf of Pearle F. Finigan, consisting of four lots and two outlots, on property generally located at North 84<sup>th</sup> Street and Waverly Road in Lancaster County, Nebraska. (See New Business Items 6A and 6B for correlating documentation.)

The Chair opened the public hearing and asked if anyone wished to testify in favor of the proposal.

The Clerk administered the oath to Lyle Loth, appearing on behalf of the applicant.

In response to a question asked by Stevens regarding access, Loth stated entrance to the lots would be off of Estes Avenue.

Hudkins asked if there would be a turnaround for emergency vehicles at the end of the service road.

Loth stated yes and that it is in place.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

### 5) **OLD BUSINESS**:

A. A contract with The Ambassador d/b/a Spectrum Rehab for physical, occupational and speech therapy services for Lancaster Manor. The term of the contract is three years with one, three year renewal option with mutual consent. All services provided will be billed by the provider direct to residents' Medicare, Medicaid and/or personal insurance company. No County funds will be paid for services rendered. (C-05-0008)

Term of the agreement is March 1, 2005 through February 28, 2006 and includes a 60 day termination clause. Hospice will bear full financial responsibility for all hospice care furnished. (C-05-0022)

Amendment No. 1 sets forth an additional consultation resource, senior consultant, for the period January 3, 2005 through January 28, 2005, at an hourly rate of \$180. (C-05-0023)
