The Board of Commissioners meeting was called to order at 1:30 p.m..

1) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, April 26, 2005.

MOTION: Workman moved and Stevens seconded approval of the minutes of the Board of Commissioners meeting dated April 26, 2005. Schorr, Stevens, Workman, Heier and Hudkins voted aye. Motion carried.

2) SPECIAL PRESENTATIONS:

- A. The Commissioners Award of Excellence was presented to Tina M. Holland, an employee with Lancaster Manor, for April, 2005.
- **MOTION:** Schorr moved and Heier seconded approval of the Commissioners Award of Excellence to Tina M. Holland for April, 2005. Workman, Schorr, Heier, Stevens and Hudkins voted aye. Motion carried.

3) CLAIMS FOR REVIEW:

A. A payment voucher, in the amount of \$4,473.68, from Sheryl Schrepf for 17 days of consulting services.

MOTION: Stevens moved and Workman seconded approval of a payment voucher, in the amount of \$4,473.68, from Sheryl Schrepf for 17 days of consulting services.

Heier asked if the County had entered into a contract with Schrepf.

Kristy Mundt, Deputy County Attorney, stated the County had no contract, however, there is a legal theory entitled quantum meruit which determines the amount to be paid when no contract exists.

- **ROLL CALL:** Stevens and Workman voted yes. Heier, Schorr and Hudkins voted no. Motion failed.
- **MOTION:** Schorr moved and Workman seconded approval of a claim for review, in the amount of \$2,200, for Sheryl Schrepf. Stevens, Workman, Schorr and Hudkins voted aye. Heier voted no. Motion carried.

5) **PUBLIC HEARINGS**:

A. An application for Corporate Manager from Kim McKay and an application for a Class I (Bottle Club) liquor license for SKM Enterprises, Inc. d/b/a Castaways Bar & Grill on Branched Oak, located at 10005 West Davey Road, Raymond, Lancaster County, Nebraska.

The Chair opened the public hearing and asked if anyone wished to testify in favor of the application.

The Clerk administered the oath to Steve and Kim McKay, applicants.

5) **PUBLIC HEARINGS CONTINUED:**

Steven McKay stated they took over operation of what was P.O. Pears on the Lake at Branched Oak Recreation Area. He added they are the current owners of Castaways at the Pawnee State Recreation Area.

In response to a question asked by Hudkins, McKay stated they have been operating under P.O. Pears' liquor license since April 1, 2005.

Discussion followed regarding proration of the license fee.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was recessed for one week.

6) NEW BUSINESS:

- A. Execution of a lease purchase agreement and related documents and a resolution approving the execution of a lease purchase agreement with Nebraska Association of County Officials (NACO) Leasing Corporation for the acquisition of one IBMz/890 Enterprise Server and an IBM Enterprise Storage Server Unit with attachments and accessories to be utilized by Lancaster County/City of Lincoln Information Services. The lease purchase agreement will begin May 5, 2005 and end May 1, 2010. The principal is \$292,417 with an interest rate of 3.350 percent. Payment will be made quarterly, in the amount of \$15,934.63, and the total payment amount is \$318,692.54. (C-05-0238 and R-05-0053)
- **MOTION:** Stevens moved and Workman seconded approval of a lease purchase agreement and related documents and a resolution approving the execution of a lease purchase agreement with Nebraska Association of County Officials (NACO) Leasing Corporation for the acquisition of one IBMz/890 Enterprise Server and an IBM Enterprise Storage Server Unit with attachments and accessories to be utilized by Lancaster County/City of Lincoln Information Services. Heier, Workman, Schorr, Stevens and Hudkins voted aye. Motion carried.

- B. An agreement with Seim, Johnson, Sestak and Quist L.L.P., to prepare and deliver the Medicare Form HCFA 2088-91-A cost report for the fiscal year ended June 30, 2005 for the Community Mental Health Center. The length of the agreement is from the date of execution until the cost report has been submitted to the County. The County will pay \$3,700 to \$4,100 for the services. (C-05-0240)
- **MOTION:** Schorr moved and Stevens seconded approval of an agreement with Seim, Johnson, Sestak and Quist L.L.P., to prepare and deliver the Medicare Form HCFA 2088-91-A cost report for the fiscal year ended June 30, 2005 for the Community Mental Health Center. Heier, Workman, Stevens, Schorr and Hudkins voted aye. Motion carried.
- C. An interlocal agreement between Lancaster County and the City of Hickman for law enforcement services through the Lancaster County Sheriff's Office. The County will assign one deputy for law enforcement purposes in the City of Hickman. The County will be paid \$6,343 per month for the services of the deputy. Term of the agreement is September 1, 2005 to August 31, 2006. (C-05-0239)
- D. An interlocal agreement with the City of Hickman for law enforcement services within the City, as needed by the City. The Sheriff will assign one deputy for duty and provide one Sheriff's cruiser. Term of the agreement is from November 1, 2005 to October 31, 2006. The County will be reimbursed at the deputy's overtime rate for the services provided and will be reimbursed 40.5 cents per mile for cruiser maintenance. (C-05-0241)

New Business Items 6C and 6D were heard together.

Terry Wagner, County Sheriff, explained Item 6C indicating the agreement was for a full-time deputy (40 hours per week) and patrol unit and had been in place for a number of years. He referred to Item 6D explaining that Hickman asked for additional coverage, on an as-needed basis, at certain times when the regular deputy was off-duty.

- **MOTION:** Stevens moved and Heier seconded approval of an interlocal agreement between Lancaster County and the City of Hickman for law enforcement services through the Lancaster County Sheriff's Office (Item 6C) and an interlocal agreement with the City of Hickman for law enforcement services within the City, as needed by the City (Item 6D).Stevens, Workman, Heier, Schorr and Hudkins voted aye. Motion carried.
- E. A Federal Equitable Sharing agreement between the Federal Government and the Lancaster County Sheriff's Office for participation in the equitable sharing program and restrictions upon the use of federally forfeited cash, property, proceeds and any interest earned. The agreement is valid through September 30, 2008. (C-05-0244)
- **MOTION:** Workman moved and Stevens seconded approval of a Federal Equitable Sharing agreement between the Federal Government and the Lancaster County Sheriff's Office for participation in the equitable sharing program and restrictions upon the use of federally forfeited cash, property, proceeds and any interest earned. Heier, Stevens, Schorr, Workman and Hudkins voted aye. Motion carried.
- F. An agreement between Lancaster County, Region V Systems and Cornhusker Place of Lincoln-Lancaster County, Inc. for Cornhusker Place to assist the County and Region V by including in the services it presently provides, the detention of individuals who are in Emergency Protective Custody (EPC) in cases in which detention at Cornhusker Place is appropriate. The agreement is effective July 1, 2005 and will expire on June 30, 2006. Any party may terminate the agreement by giving 60 days written notice. (C-50-0245)
- **MOTION:** Heier moved and Stevens seconded approval of an agreement between Lancaster County, Region V Systems and Cornhusker Place of Lincoln-Lancaster County, Inc. for Cornhusker Place to assist the County and Region V by including in the services it presently provides, the detention of individuals who are in Emergency Protective Custody (EPC) in cases in which detention at Cornhusker Place is appropriate. Workman, Schorr, Stevens, Heier and Hudkins voted aye. Motion carried.

G. A subordination agreement between Lancaster County, West Gate Bank and U.S. Foods L.L.C. allowing U.S. Foods, L.L.C. to refinance with West Gate Bank. West Gate Bank will replace the existing senior lien holder. The position of Lancaster County's lien filed as collateral for a Community Development Block Grant (CDBG) funded economic development job creation loan will remain unchanged. (C-05-0246)

Troy Gagner, Economic Development Coordinator, explained the subordination agreement was to refinance the existing the loan with a different bank.

- **MOTION:** Workman moved and Heier seconded approval of a subordination agreement between Lancaster County, West Gate Bank and U.S. Foods L.L.C. allowing U.S. Foods, L.L.C. to refinance with West Gate Bank. Stevens, Workman, Heier, Schorr and Hudkins voted aye. Motion carried.

An amendment to an agreement with Family Services d/b/a CF Star, under County Contract C-04-0274, for wraparound services to youth who are wards of the State of Nebraska Health and Human Services Southeastern Service Area and reside in Lancaster County. The County desires additional care coordinators and as a result, the parties wish to amend the compensation from \$407,796.72 to \$427,654.57. (C-05-0237)
