The Board of Commissioners meeting was called to order at 1:30 p.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, October 4, 2005.

- A. The County-City Volunteer of the Month Award was presented to Rebekah Greenwalt for her services with Parks and Recreation.
- B. Introduction of Gary Hamilton Dan Morgan, Good News Jail and Prison Ministries; Mike Thurber, Corrections Director

Mike Thurber, Corrections Director, introduced Dan Morgan, Chaplain at the Corrections Department.

2) **SPECIAL PRESENTATIONS:**

Morgan introduced Gary Hamilton, Chairman of the President's Council and indicated Mr. Hamilton is also a volunteer with the ministry program at Corrections. He explained that the ministry relies on contributions from individuals, churches, special events and corporations and that Mr. Hamilton assists him with those duties. Term of the agreement is July 1, 2005 through June 30, 2006. The County will pay up to \$20,000 for such services. (C-05-0504)

Heier indicated he would abstain from voting because he is a member of the Board of Directors of the Child Advocacy Center.

It is also recommended the County Board approve a service guarantee stating the seller will pay for all costs of parts and labor in excess of \$5,500 per unit during the next seven years or 8,500 hours (\$16,500 total) and the guaranteed repurchase of \$83,000 per motor grader after seven years (\$249,000 total backed by performance bond as detailed in the specification).
