The Board of Commissioners meeting was called to order at 1:30 p.m..

- 1) **MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, November 1, 2005.**

MOTION: Heier moved and Workman seconded approval of the minutes of the Board of Commissioners meeting dated November 1, 2005. Schorr, Stevens, Workman, Heier and Hudkins voted aye. Motion carried.

- 2) **SPECIAL PRESENTATIONS:**

A. Oath of Office - Travis Roth, Deputy County Sheriff

Terry Wagner, County Sheriff, introduced Travis Roth stating he is from Chapell, Nebraska and recently received his Bachelor of Science degree from the University of Nebraska-Lincoln. He added that Roth interned with the Sheriff's Office approximately three years ago and has most recently been a police officer in Central City, Nebraska.

Chief Deputy County Clerk, Trish Owen, administered the oath of office to Roth.

B. The Commissioners' Award of Excellence for October, 2005 was presented to Stacey Sheehan, an employee at Lancaster Manor.

3) **CLAIMS:** Approval of all claims processed through Tuesday, November 8, 2005.

MOTION: Heier moved and Stevens seconded approval of all claims processed through November 8, 2005. Workman, Stevens, Schorr, Heier and Hudkins voted aye. Motion carried.

4) **PUBLIC HEARINGS:**

A. County Special Permit No. 05047, requested by Brian D. Carstens and Associates on behalf of David and Lynette Samani, to allow a private recreation cabin under the provisions of Article 13.001(10) of the Lancaster County Zoning Resolution, on property generally located at the northwest corner of Southwest 84th Street and Kolbrook Road in Lancaster County, Nebraska. (See New Business Item 5A for correlating documentation.)

The Chair opened the public hearing and asked if anyone wished to testify.

The oath was administered to Jill Schuerman, appearing on behalf of Brian D. Carstens and Associates and David and Lynette Samani.

Schuerman gave an overview of the proposal indicating the cabin would be used two days a week. She displayed photographs of the outside and inside of the cabin noting that it is being used as a cabin and not as an office. Schuerman also pointed out that the cabin is meeting the requirement that it be setting on block.

In response to a question asked by Schorr, both Schuerman and Samani indicated there is no intent to expand the cabin.

Stevens stated it was understanding there were large yard lights installed and asked if they were in conjunction with the cabin.

The oath was administered David Samani, applicant.

Samani stated there are large lights installed on the barn, not on the cabin.

Heier asked about recourse if the cabin is used for more days than allowed.

The oath was administered to Mike DeKalb, Planning Department.

4) **PUBLIC HEARINGS CONTINUED:**

DeKalb stated there are provisions in the special permit language which specifically say the cabin shall not be used as a permanent residence. He stated if the cabin should be used as a permanent residence and complaints are filed with Building and Safety, they would advise the owner to cease that operation. If operation is not ceased, the special permit can be revoked or it can be turned over to the County Attorney's Office.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

B. County Miscellaneous No. 05024, requested by the Director of Planning, to amend the Lancaster County Land Subdivision Resolution to allow the Director of Planning to approve County final plats and to allow County community unit plans to be submitted without a preliminary plat. (See New Business Item 5B for correlating documentation.)

The Chair opened the public hearing and asked if anyone wished to provide testimony.

The oath was administered to Tom Cajka, Planning Department.

Cajka gave a brief overview of County Miscellaneous No. 05024.

Heier inquired about the time frame of an appeal.

Cajka stated there is a two week period to submit an appeal after the final plat is signed by the Director.

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

4) **PUBLIC HEARINGS CONTINUED:**

Continuation of a public hearing regarding County Special Permit No. 04055, Four Stones Community Unit Plan, requested by Matt Langston of ESP on behalf of Craig Gana, to develop fourteen residential acreage units on property generally located in the mile section bounded by Southwest 14th Street to Southwest 29th Street and West Stagecoach Road to West Panama Road in Lancaster County, Nebraska. (See New Business Item 5C for correlating documentation.)
- D. Continuation of a public hearing regarding County Preliminary Plat No. 04025, Four Stones, requested by Matt Langston of ESP on behalf of Craig Gana, to develop 14 residential acreage lots and four outlots on property generally located in the mile section bounded by Southwest 14th Street to Southwest 29th Street and West Stagecoach Road to West Panama Road in Lancaster County, Nebraska. (See New Business Item 5D for correlating documentation.)

Board consensus to reconvene both Public Hearing Items 4C and 4D together.

The Chair reconvened the public hearings.

The oath was administered to Kent Seacrest, attorney representing of the applicant.

Seacrest briefly summarized the proposals stating the Sprague Village Board approved both the community unit plan and the preliminary plat. He added that they feel the project is in conformance with the Comprehensive Plan and that they are in concurrence with all staff conditions and support.

The Chair asked if anyone else wished to testify.

No one appeared and the hearings were closed.

Heier suggested that a condition be placed on the special permit relating to renewal.

MOTION: Stevens moved and Heier seconded to amend the motion to add Condition 3 indicating that the special permit expires five years from the date of approval. Application for renewal for an additional five years shall be at the discretion of the County Board. Stevens, Heier, Schorr and Hudkins voted aye. Workman voted no. Motion carried.

Workman, Schorr, Stevens, Heier and Hudkins voted aye. Motion carried.

A resolution in the matter of authorizing the Lincoln-Lancaster County Public Building Commission to purchase Lots 11 and 12, Block 130, Original Plat and Lots A and B, Billingsley's Subdivision of Lot 1, and all of Lot 2, Block 145, Original Plat of Lincoln, Lancaster County, commonly known as 645 and 701 South 9th Street for joint use by the City of Lincoln and Lancaster County. (R-05-0145)**

MOTION: Workman moved and Heier seconded approval of Resolution 05-0145 in the matter of authorizing the Lincoln-Lancaster County Public Building Commission to purchase Lots 11 and 12, Block 130, Original Plat and Lots A and B, Billingsley's Subdivision of Lot 1, and all of Lot 2, Block 145, Original Plat of Lincoln, Lancaster County, commonly known as 645 and 701 South 9th Street for joint use by the City of Lincoln and Lancaster County.

Stevens inquired about the condition of the roof and the heating/air conditioning system, status of equipment in unoccupied areas of the building and the lease rate.

Kristy Mundt, Deputy County Attorney, stated the City held the resolution approving the project, however, the City Attorney indicated they would vote on the resolution with the bonds. She added that she received a copy of a report to Don Killeen, County Property Manager, regarding the inspections, however, had not had time to review the information.

Lauren Wismer, bond counsel, appeared and gave a brief summary regarding the resolution and added Public Building Commission statutes also require that the County and City approve the issuance of bonds. Acquisition of the building should be completed by January 1, 2006.

MOTION: Heier moved and Workman seconded approval of Resolution 05-0144 approving a site lease from the County of Lancaster and the City of Lincoln, Nebraska to the Lincoln-Lancaster County Public Building Commission, a lease agreement from the Commission to the County and the City and the issuance of not to exceed \$2,000,000 of the Commission's Tax Supported Lease Rental Revenue Bonds, Series 2005, all with respect to the acquisition of the Courthouse Plaza Building. Stevens, Schorr, Heier, Workman and Hudkins voted aye. Motion carried.
