- H. A grant contract with the Good Neighbor Center to provide an emergency food and clothing center for low income families in the Lincoln/Lancaster County area, in the amount of \$57,000. Term of the grant contract is July 1, 2006 through June 30, 2007. (C-06-0517)

- I. A grant contract with Lincoln Medical Education Partnership to provide funding for the Family Violence Council Program, in the amount of \$25,883, and the Pathways to Self-Sufficiency through Education Program, in the amount of \$30,500. The total amount of the grant contract is \$56,383. Term of the grant contract is from July 1, 2006 through June 30, 2007. (C-06-0518)
- J. An agreement with the Lancaster County Medical Society (LCMS) to enroll qualified Lancaster County General Assistance clients in national pharmaceutical discount programs and to provide related services, including medical record development, the training of General Assistance caseworkers and the training of staff at the Community Mental Health Center. Term of the agreement is July 1, 2006 through June 30, 2007. The County will reimburse LCMS based upon the established rates for each discount program and \$2,000 per month for related services. The County will also reimburse LCMS \$3,000 for training the staff at the Community Mental Health Center. (C-06-0519)
- K. An interlocal agreement with the Village of Denton for law enforcement services within the Village limits. The Lancaster County Sheriff will assign one Deputy to duty in the Village limits and provide a cruiser. The Village will reimburse the County at the overtime rate of pay for the Deputy assigned. Term of the agreement will be from September 1, 2006 to August 31, 2007. (C-06-0520)
- L. An interlocal agreement with the City of Hickman for the provision of law enforcement services within the City, as needed by the City. The Sheriff will assign one Deputy for duty and provide one Sheriff's cruiser. Term of the agreement is from November 1, 2006 to October 31, 2007. The County will be reimbursed at the Deputy's overtime rate for the services provided and will be reimbursed 44.5 cents per mile for cruiser maintenance. (C-06-0521)
- M. Agreement and acceptance of proposal with the Lincoln League of Women Voters to assist with voter registration sites in Lancaster County. The County will pay up to \$2,000 for the services. Term of the agreement is September 1, 2006 to August 31, 2007. (C-06-0522)
- N. An agreement between Lancaster County, on behalf of the Lancaster County Election Commissioner, and Steve McClatchey for the delivery of voting machines and other miscellaneous equipment to several polling locations for the Statewide Primary Election for Lancaster County on November 7, 2006.
