The Board of Commissioners meeting was called to order at 1:30 p.m..

3) **NEW BUSINESS**:

A. An application for a Special Events Permit from Great Plains Bicycling Club to hold the Spring Fling Metric Century Bike Tour on Saturday, April 22, 2006, beginning at 9 a.m..

Steven Clements, Treasurer of Great Plains Bicycling Club, appeared and gave a brief overview of the bicycle tour, noting they have no objections to any conditions outlined by the Sheriff or the County Engineer.

Term of the grant contract is January 1, 2006 to December 31, 2006. (C-06-0050)

Stevens, Heier, Workman and Hudkins voted aye. Motion carried.
- D. A grant contract with the Hispanic Community Center to provide funding for the community-driven initiatives to address violence against women among diverse and traditionally under served populations while strengthening legal advocacy services for victims of domestic abuse and dating violence, in the amount of \$44,063. Term of the grant contract is January 1, 2006 to December 31, 2006. (C-06-0051)

- E. A contract with Brandt Excavating, in the amount of \$136,407.19, for erosion control at various box culverts and bridges within Lancaster County; Project 06-25. The work will begin on March 27, 2006 and be completed by September 1, 2006. (C-06-0052)

- G. Harvest Project contract with the Lincoln Area Agency on Aging (LAAA) for the provision of mental health, substance abuse and aging services to elderly residents of Lancaster County. LAAA will provide Specialized Care Managers to work 40 hours per week to assist in the provision of the services. The County will pay \$50,000 for the services. Term of the contract is July 1, 2005 and ends June 30, 2006. (C-06-0054)
- **MOTION:** Heier moved and Hudkins seconded approval of a Harvest Project contract with the Lincoln Area Agency on Aging (LAAA) for the provision of mental health, substance abuse and aging services to elderly residents of Lancaster County. Stevens, Workman, Heier and Hudkins voted aye. Motion carried.
- H. An agreement between Lancaster County and CenterPointe for the services of a program director and a case manager for the Partners in Empowerment and Recovery (PIER) program. Term of the agreement is July 1, 2005 through June 30, 2006. CenterPointe will pay the County \$137,834.50 for the services. (C-06-0055)
- **MOTION:** Stevens moved and Hudkins seconded approval of an agreement between Lancaster County and CenterPointe for the services of a program director and a case manager for the Partners in Empowerment and Recovery (PIER) program.

Heier stated he would like to make sure that it's understood if the fees exceed the contract price, the State would reimburse the County for those costs. He also addressed concerns regarding the Program Director and Case Manager positions should the contract lapse or there not be appropriate reimbursement.

FRIENDLY AMENDMENT: Heier offered a friendly amendment specifying that there be no cost to the County and that the positions of Program Director and Case Manager, employed by the County, terminate should the contract lapse or appropriate reimbursement fails.

Both the maker of the motion and the seconder agreed to the friendly amendment.

1. An interlocal agreement between Lancaster County and the City of Lincoln for the adoption of right-of-way and construction standards for unimproved county roads located with the three-mile zoning jurisdiction of the City of Lincoln classified as rural principal arterial, rural minor arterial, rural major collector and rural minor collector in the Lincoln-Lancaster County Comprehensive Plan. The agreement will commence upon execution by both parties and remain in effect until such time as it is terminated. The County will pay the cost of right-of-way and easement acquisition, and design and construction costs for grading the road to its full width, installing urban culverts and rural paving. (C-06-0060)

Don Thomas, County Engineer, explained they would be building a new type of roadway which will blend easier when the City annexes County roads. He also indicated that the contract recognizes those design standards.

Workman, Hudkins, Stevens and Heier voted aye. Motion carried.
