The Board of Commissioners meeting was called to order at 9:30 a.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, August 8, 2006.

MOTION: Hudkins moved and Stevens seconded approval of the minutes of the Board of Commissioners meeting held on August 8, 2006. Hudkins, Stevens, Workman, Heier and Schorr voted aye. Motion carried.

2) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, August 15, 2006.

MOTION: Workman moved and Heier seconded approval of all claims processed through August 15, 2006. Workman, Hudkins, Heier, Stevens and Schorr voted aye. Motion carried.

3) **NEW BUSINESS**:

A. A consulting services agreement with CD Group, Inc. for assessment and training of Information Services employees with regard to the County's financial system (PeopleSoft). The agreement is effective for a one year term upon execution by both parties. The County will pay \$7,200 for such training services. (C-06-0462)

MOTION: Workman moved and Stevens seconded approval of a consulting services agreement with CD Group, Inc. for assessment and training of Information Services employees with regard to the County's financial system (PeopleSoft). Heier, Workman, Stevens, Hudkins and Schorr voted aye. Motion carried.

B. An interlocal agreement between Lancaster County and the City of Lincoln to obtain preliminary design and corridor protection plans for the East Beltway. The City and County will contribute equally the local matching portion of the federal funds, not to exceed \$300,000 each. (C-06-0464)

Heier declared a conflict of interest and noted he would abstain from voting.

MOTION: Hudkins moved and Stevens seconded approval of an interlocal agreement between Lancaster County and the City of Lincoln to obtain preliminary design and corridor protection plans for the East Beltway. Workman, Stevens, Hudkins and Schorr voted aye. Heier abstained from voting. Motion carried.

Stevens stated the share of the County's commitment would be taken from the proceeds of Keno and not property tax funds.

C. An interlocal agreement with the City of Waverly for the provision of two Sheriff's Deputies to provide law enforcement services within the corporate limits of the City of Waverly. Term of the agreement is from October 1, 2006 to September 30, 2007 and the County will be reimbursed up to \$153,046.63. (C-06-0465)

The agreement is effective July 1, 2006 and will expire on June 30, 2007. Any party may terminate the agreement by giving 60 days written notice. (C-06-0466)

Heier, Workman, Hudkins, Stevens and Schorr voted aye. Motion carried.

An agreement between Olsson Associates and Lancaster County to allow Olsson to utilize the County's right-of-way for soil boring tests at various locations between North 98th Street and Alvo Road and North 190th Street and Waverly Road. The work will commence upon execution of the agreement and be completed by September 30, 2006. (C-06-0467)
