The meeting of the Board of Commissioners was called to order at 9:30 a.m..

1) **MINUTES:** Approval of the minutes of the Board of Commissioners meeting held on Tuesday, January 9, 2007.

MOTION: Heier moved and Stevens seconded approval of the minutes of the Board of Commissioners meeting dated January 9, 2007. Hudkins, Stevens, Schorr, Heier and Workman voted aye. Motion carried.

4) **PUBLIC HEARINGS:**

A. Issuance of bonds by Hospital Authority No. 1 of Lancaster County, Nebraska, in an amount not to exceed \$90,000,000, relating to refunding the Series 2001 bonds for BryanLGH Medical Center and related approval required by the Internal Revenue Code. (See New Business Item 5A for correlating documentation.)

The Chair opened the public hearing and asked if anyone wished to provide testimony.

The Clerk administered the oath to Lauren Wismer, bond counsel.

Wismer indicated the bonds will refund bonds which were issued in 2001. He explained that BryanLGH has the opportunity to achieve present value savings in excess of \$3,000,000 by refunding the bonds.

The Chair asked if anyone else wished to provide testimony.

No one appeared and the hearing was closed.

5) **NEW BUSINESS:**

Discussion took place regarding the daily per diem rate.

The meeting of the Board of Equalization was called to order at 10:16 a.m..

1) <u>MINUTES:</u> Approval of the minutes of the Board of Equalization meeting held on Tuesday, January 9, 2007.

MOTION: Schorr moved and Heier seconded approval of the minutes of the Board of Equalization meeting dated January 9, 2007. Hudkins, Stevens, Schorr, Heier and Workman voted aye. Motion carried.

2) ADDITIONS AND DEDUCTIONS:

Approval of 253 additions and deductions to the tax assessment rolls per Attachment "A".

MOTION: Hudkins moved and Stevens seconded approval of the additions and deductions to the tax assessment rolls. Schorr, Hudkins, Heier, Stevens and Workman voted aye. Motion carried.

3) MOTOR VEHICLE TAX EXEMPTIONS:

MOTION: Heier moved and Hudkins seconded approval of the motor vehicle tax exemptions. Heier, Schorr, Stevens, Hudkins and Workman voted aye. Motion carried.

4) APPEAL FILED ON ASSESSED VALUATION CHANGE FOR 2006:

Roger and Eldonna Schwisow Trustees (Parcel I.D. # 18-32-200-005-000)

Roger Schwisow, property owner, appeared and stated the property immediately surrounding his is valued substantially lower. He stated he would like to be treated equally with surrounding property.

In response to a question asked by Hudkins, Schwisow stated his property is level and buildable as is the neighboring property.

Michelle Slack, Appraisal Supervisor in the County Assessor/Register of Deeds Office, appeared and stated the recapture value was \$64,000 and was based on a clerical error made by the referee during the property valuation protests. She stated the property consists of 61.68 acres of which 18.37 acres is valued at zero because of a Natural Resources District (NRD) conservation easement. After review by the Referee Coordinator, she said, the value was determined to be \$30,000 an acre for the remaining 43.31 acres. Recommendation from the County Assessor/Register of Deeds Office was to leave 18.37 acres at zero and apply a value of \$15,000 per acre on the remaining 43.31 acres for a total value of \$649,650.

MOTION: Schorr moved and Hudkins seconded to accept the recommendation from the County Assessor/Register of Deeds Office and set a new value of \$15,000 per acre on 43.31 acres for a total value of \$649,650 and leave 18.37 acres at zero due to a conservation easement. Schorr, Stevens, Hudkins, Heier and Workman voted aye. Motion carried.

5) **RECONSIDERATION OF 2005 AND 2006 HOMESTEAD EXEMPTION:**

James F. and Kimberly S. McFarland

James McFarland appeared and gave an overview of the circumstances surrounding his request to reconsider the homestead exemption for 2005 and 2006.

Scott Gaines, Deputy County Assessor/Register of Deeds, and Jill Cook, Personal Property/Homestead Exemption Supervisor, appeared. Gaines explained that the statutes do provide for an extension for those individuals who miss the filing deadline of June 30th. To receive the extension, he explained, those individuals must submit a letter to the Board of Equalization, no later than July 20th of each year, indicating they are filing their homestead exemption late, and that they are requesting an extension of the deadline. He added that the completed exemption application must also be submitted with the extension request. Gaines stated the only stipulation to the statute is that individuals cannot request an extension for consecutive years. Because the Assessor's Office never received the paperwork from Mr. McFarland they couldn't forward it to the Board for consideration.

In response to a statement made by Stevens regarding the application dated June 28, 2005, Gaines stated that Cook had visited with Mr. McFarland regarding the necessary steps for requesting an extension deadline, however, their office never received any documentation in the mail.

Cook stated she had also mailed Mr. McFarland an affidavit to be completed and to be enclosed with their documentation, however, it was never received.

MOTION: Heier moved and Schorr seconded to deny the reconsideration of a homestead exemption for James F. and Kimberly S. McFarland for 2005 and 2006. Stevens, Heier, Schorr, Hudkins and Workman voted aye. Motion carried.

6) NOTICE OF ASSESSED VALUATION CHANGE FOR PROPERTY TAXATION PURPOSES:

Dan and Patricia Kreitman

MOTION: Schorr moved and Hudkins seconded to accept the recommendation of the Deputy County Assessor/Register of Deeds and send notice of assessed valuation change to Dan and Patricia Kreitman. Heier, Schorr, Hudkins, Stevens and Workman voted aye. Motion carried.
