The meeting of the Board of Commissioners was called to order at 9:30 a.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, January 23, 2007.

MOTION: Heier moved and Stevens seconded approval of the minutes of the Board of Commissioners meeting held on January 23, 2007. Hudkins, Stevens, Schorr, Heier and Workman voted aye. Motion carried.

2) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, January 30, 2007.

MOTION: Stevens moved and Schorr seconded approval of all claims processed through January 30, 2007. Schorr, Hudkins, Heier, Stevens and Workman voted aye. Motion carried.

3) **SPECIAL PRESENTATIONS:**

A. The Commissioners' Award of Excellence for January, 2007 was presented to Nikita Pavlovic, an employee with Lancaster Manor.

MOTION: Hudkins moved and Heier seconded approval of the Commissioners' Award of Excellence for January, 2007 to Nikita Pavlovic, an employee with Lancaster Manor. Heier, Schorr, Stevens, Hudkins and Workman voted aye. Motion carried.

3) **SPECIAL PRESENTATIONS CONTINUED:**

B. Resolution No. 07-0010 in the matter of supporting the adoption of the National Standards of Practice for Interpreters in Health Care (R-07-0010) - Kit Boesch, Human Services Director, and Helen Fagen, Diversity Coordinator for BryanLGH Medical Center

Appearing were Kit Boesch, Human Services Director, and Helen Fagen, Diversity Coordinator for BryanLGH Medical Center, to request the Board's support and approve the resolution.

The Clerk read the resolution into the record.

MOTION: Stevens moved and Schorr seconded approval of Resolution 07-0010 in the matter of supporting the adoption of the National Standards of Practice for Interpreters in Health Care. Heier, Schorr, Stevens, Hudkins and Workman voted aye. Motion carried.

4) **PUBLIC HEARINGS:**

A. County Special Permit No. 06058, requested by U.S. Cellular Wireless Communications, for authority to construct a 199 foot tower for wireless facilities on property generally located southwest of the intersection of West Alvo Road and Northwest 126th Street, Lancaster County, Nebraska. (See New Business Item 5A for correlating documentation.)

The Chair opened the public hearing and asked if anyone wished to provide testimony in favor of the proposal.

The Clerk administered the oath to Harvey Cooper, attorney representing U.S. Cellular Wireless Communications, and Patrick Armstrong, Radio Frequency Engineer for U.S. Cellular.

Cooper submitted written testimony of Patrick Armstrong regarding County Special Permit (Exhibit A).

4) **PUBLIC HEARINGS CONTINUED:**

Cooper gave a brief background of the site explaining that the area was served by Western Wireless primarily operating on an 800 megahertz band. Alltel purchased the assets of Western Wireless in 19 states, including Nebraska, and as a part of the approval process the Federal Communications Commission (FCC) required Alltel to divest all of the sites in Nebraska with the exception of Lancaster and Douglas counties. Cooper said U.S. Cellular took over Western Wireless in January of 2006. He said U.S. Cellular traditionally operates on a 1900 megahertz band, however, the Western Wireless sites operate on the 800 megahertz band and they need a way to make the 1900 system 'talk' to the 800 system. Cooper stated there are also other critical mandates which the FCC has imposed; one of those being that the 800 megahertz system remain as it is. Cooper stated the most critical gap in coverage is on Highway 34 which will be taken care of by the current proposal.

Patrick Armstrong, radio frequency engineer, stated the existing system in Lancaster County is 1900 megahertz. He explained that the license area and its frequency changes to 800 megahertz upon entering Seward County. Armstrong referred to a map showing the proposed coverage area stating they are trying to provide 1900 megahertz coverage to overlap into the 800 megahertz coverage area and allow for a clean hand-off to eliminate dropped calls.

Armstrong addressed the following alternate locations, noting that none of those sites were acceptable due to attenuation and coverage holes:

- Existing Valcom site south of Malcolm (195 feet extendable up to 490 feet)
- Existing Alltel site north of Malcolm
- Malcolm Water Tank with a 60 foot extension

Armstrong stated the proposed site is the best solution for the area. It causes no interference in the existing system, it provides a clean hand-off point, and it fills in the coverage holes along Highway 34. He added the site fills the significant gap they have currently and allows them to connect the existing 1900 megahertz to the acquired Project Heartland (Western Wireless).

Discussion focused on the reasons why coverage is difficult to acquire such as terrain and indoor/outdoor coverage.

In response to a reference by Hudkins to a map (Exhibit B) the Board received from Doug Ahlberg, Emergency Services Director, Kerry Eagan, Chief Administrative Officer, explained Ahlberg had indicated that existing gaps in coverage for the Lancaster County Emergency Services would not be improved by placing an antenna at 150 feet on the new tower.

4) **PUBLIC HEARINGS CONTINUED:**

Captain Bill Jarrett, Lancaster County Sheriff's Office, appeared and stated he would not want to rule out the possibility of accessing the tower for possible use.

OPPOSITION

The following individuals were administered the oath and appeared in opposition of the proposal expressing concerns regarding no wireless coverage for residents of Malcolm, failure to thoroughly explore collocation on existing towers such as Capital Tower near Garland, aesthetics, and loss of agricultural land:

The Chair asked if anyone else wished to provide testimony.

No one appeared.

In conclusion, Cooper reiterated that the intent of U.S. Cellular Wireless is to achieve a good, clean hand-off on Highway 34 to eliminate dropped calls.

Armstrong addressed the following: *Radio Frequency Analysis and Report* (Exhibit C) submitted by Shelton, extension of U.S. Cellular's existing 800 megahertz system into Lancaster County, coverage in Malcolm, and collocation on Capital Tower near Garland, Nebraska.

In response to a question asked by Schorr, Brian Wills, Planning Department, stated he felt U.S. Cellular Wireless had explored alternatives to building a new tower and had followed the process.

4) **PUBLIC HEARINGS CONTINUED:**

The Clerk administered the oath to Kristy Bauer, Deputy County Attorney.

In response to a question asked by Schorr regarding which section of the Federal Communications Act is being followed, Bauer stated the proposal would fall under 47 United States Code §332. Bauer stated the Federal Telecommunications Act of 1996 does place limitations on local government and their ability to regulate the location and construction of facilities for wireless communications. She stated that the Act further provides that any decision by a local government to deny a request to construct a wireless facility must be in writing and supported by substantial evidence contained in the written record. Bauer also pointed to a case, *USCOC of Greater Iowa vs. the City of Bellevue*, 279 F.Supp 2D 1080, in which several owners voiced aesthetic concerns and concerns regarding decreased property valuations if a tower was erected in their area. The Court held that aesthetic concerns, decreased property values and in general, 'not in my back yard', is not substantial evidence to deny a request for a wireless tower.

The Chair closed the public hearing.

MOTION: Hudkins moved to hold County Special Permit No. 06058 for 120 days and encourage the applicants to seek collocation and to provide improved service for the Malcolm area.

Motion failed for lack of a second.

Workman requested photographs of downtown Lincoln taken in the 1880's be displayed showing numerous telephone poles and telephone lines.

The agreement is effective upon execution of both parties and contains a 30 day termination provision. (C-07-0033)
