The location announcement of the Nebraska Open Meetings Act was given and the meeting of the Lancaster County Board of Commissioners was called to order at 9:30 a.m..

**MOTION:** Stevens moved and Hudkins seconded approval of the minutes of the Board of Commissioners meeting held on April 3, 2007. Hudkins, Stevens, Schorr and Workman voted ave. Heier abstained from voting.

- A. The Commissioners Award of Excellence for March, 2007 was presented to Captain Todd Duncan with the Lancaster County Sheriff's Office.
- B. Letter of Support for Lincoln Convention and Visitors Bureau bids for Nebraska High School State Championships for Golf, Tennis, Baseball, Swimming and Diving

Jeff Maul, Executive Director of the Lincoln Convention and Visitors Bureau, appeared and stated they would bidding on State Championships for golf, tennis, baseball, swimming and diving on Thursday, April 12, 2007.

**MOTION:** Stevens moved and Heier seconded approval of a letter of support for Lincoln Convention and Visitors Bureau bids for Nebraska High School State Championships for golf, tennis, baseball, swimming and diving. Schorr, Stevens, Hudkins, Heier and Workman voted aye. Motion carried.

Terry Wagner, County Sheriff, stated he wasn't sure. He stated he did review the diagram, but didn't know if the event would be held in the parking lot. Wagner stated one of the suggestions made by the investigator who completed the guidelines was to make sure that the square footage of the building was adequate to house the number of patrons who would be attending the event.

Schorr noted that the Sheriff's recommendation also indicates the applicant would need an amusement license and stated she would feel more comfortable holding the application for a special designated license until they receive more information about the event.

- C. An application for a Special Events Permit from Midwest Wheel Events to hold the Lincoln Plating Spring Cycling Classic on Saturday, April 21, 2007 from 8 a.m. to 6 p.m. at Branched Oak Lake. The race will begin at Lieber's Point and proceed clockwise around the lake using Northwest 140<sup>th</sup> Street, West Davey Road, Northwest 98<sup>th</sup> Street, West Raymond Road and Branched Oak Road and end back at Lieber's Point.

Appearing to answer questions was John Lefler, Jr., applicant.

An interlocal agreement between the City of Lincoln and Lancaster County to provide the City with an appropriate facility at the Youth Services Center for detention of juveniles taken into custody by the Lincoln Police Department. The agreement is effective upon execution and continues through June 30, 2007 with automatic renewal for successive periods of one year unless either party provides written notice of its intention to renegotiate or terminate the agreement at least 90 days prior to the anniversary date. The agreement supercedes and replaces the previous interlocal agreement executed by the County on May 9, 1989 under County Contract No. C-4891. (C-07-0126)

**MOTION:** Heier moved and Stevens seconded approval of an interlocal agreement between the City of Lincoln and Lancaster County to provide the City with an appropriate facility at the Youth Services Center for detention of juveniles taken into custody by the Lincoln Police Department. Hudkins, Stevens, Schorr, Heier and Workman voted aye. Motion carried.

E. A contract between the Nebraska Volunteer Service Commission and Lancaster County, on behalf of the Lancaster County Emergency Management Department, to implement Citizen Corps Program (CCP) services through the local Citizen Corps Council to give citizens opportunities to work with local first responders in preparing, training, and volunteering to make local communities safer. Term of the contract is January 1, 2007 through December 31, 2007. The County will receive \$22,810 from the State to provide such services. (C-07-0127)

A contract between the Lancaster County Engineering Department and Shanahan Brothers Construction, Inc., in the amount of \$651,032.37, for grading construction and culvert work at the intersection of Southwest 2<sup>nd</sup> Street and Panama Road, South 82<sup>nd</sup> Street from Panama Road to Hickman Road, Northwest 70<sup>th</sup> and West Superior Streets and West "A" Street from Southwest 84<sup>th</sup> Street to the Burlington Northern Sante Fe Railroad crossing. The contract will be effective upon execution. (C-07-0128)
