The Clerk administered the oath to Jim Partington, applicant and President of Deer Springs Winery L.L.C..

Partington stated the request is Phase II of the original application submitted and explained that they are remodeling the farm house so that it can be used as a tasting room. He explained that they were doing it in phases because a building permit was needed for the remodel of the farm house and they also needed to resurvey 80 acres to satisfy the requirements of the Zoning Commission.

Hudkins stated the County Board would appreciate hearing Mr. Partington's comments regarding the Planning process upon completion of his facility.

Heier concurred.

#### 4) **NEW BUSINESS**:
