The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:30 a.m..

1) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, June 5, 2007.

MOTION: Stevens moved and Heier seconded approval of the minutes of the Board of Commissioners meeting held on June 5, 2007. Hudkins, Stevens, Schorr, Heier and Workman voted aye. Motion carried.

2) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, June 12, 2007.

MOTION: Heier moved and Schorr seconded approval of all claims processed through June 12, 2007. Schorr, Hudkins, Heier, Stevens and Workman

voted ave. Motion carried.

3) **SPECIAL PRESENTATIONS:**

A. The Commissioners Award of Excellence for May, 2007 was presented to Tinh Tran with the County/City Property Management Department.

MOTION: Hudkins moved and Schorr seconded approval of the Commissioners Award of Excellence for May, 2007 to Tinh Tran with County/City Property Management. Heier, Schorr, Stevens, Hudkins and Workman voted aye. Motion carried.

4) **PUBLIC HEARINGS**:

A. Continuation of a public hearing regarding a request from Ron's Pub Inc. d/b/a Ron's Pub for an addition to licensed premise located at 13940 "O" Street, Suite B8, Lincoln, Lancaster County, Nebraska. This request is for a banquet hall (Oasis Room) next to Ron's Pub. (See New Business Item 5A for correlating documentation.)

The Chair reconvened the public hearing.

Bob Creager, attorney for Ron's Pub, gave a brief overview of the request and indicated they are taking the County Board's concerns seriously and are willing to ask for the Board's approval of the request conditioned upon Mr. Skoda not being the manager.

Hudkins referred to County Resolution No. 05-0052, dated April 21, 2005, which outlines the procedures and standards for administering applications for liquor license within Lancaster County. He noted that Section V states, "Qualified applicants: The applicants shall show by a preponderance of evidence that the type of management and control exercised over the licensed premise shall be sufficient to ensure that the licensed business can conform to all requirements, rules and regulations."

Creager stated Mr. Skoda signed the application on behalf of the corporation, Ron's Pub, Inc., which is requesting an addition to licensed premises.

Discussion took place regarding pending charges relating to Ron Skoda and Judy Swanson. Terry Wagner, Lancaster County Sheriff, referred to the latter individual indicating that individual was arrested a second time on May 18, 2007 for DWI, as well as the previous arrest in December, 2006.

4) **PUBLIC HEARINGS CONTINUED:**

The oath was administered to Rita Skoda, Keno Manager at Ron's Pub, Inc..

In response to a question asked by Heier relating to the manager on duty on May 18, 2007, Ms. Skoda responded Suzanne Miller was managing that evening.

Schorr inquired about Ms. Skoda's management experience.

Ms. Skoda stated she has managed business offices and ran her own business for two and a half years. She added she has also taken some business administration classes at the college level and has instituted a dress code at Ron's Pub and is currently working on an employee handbook as well as rules and regulations for the establishment and forms documenting shift changes. Ms. Skoda reported she has also held a mandatory employee meeting and has requested an application to enroll in the responsible hospitality/management training course through the Lincoln Police Department as well as requesting LPD to present a workshop for staff at Ron's Pub.

Entered into the record was a copy of the employee handbook for Ron's Pub (Exhibit 1).

The Chair asked if anyone else wished to testify.

No one appeared and the hearing was closed.

B. Proposed revisions to the Lincoln-Lancaster County Air Pollution Control Program Regulations and Standards. (A copy of the proposed revisions is available in the County Clerk's Office for viewing.) (See New Business Item 5B for correlating documentation.)

The Chair opened the public hearing and asked if anyone wished to testify.

The oath was administered to Richard Thorson, Environmental Health Supervisor with the Lincoln-Lancaster County Health Department.

Thorson highlighted the following changes in the regulations and standards:

- Definition of crematory
- Correction of a typographical error
- Incorporate changes made at the Federal level regarding the national ambient air quality standards
- Change regulations to allow for the reduction of paperwork regarding crematories, both human and animal
- Incorporate changes regarding larger incinerators
- Add new standards for new sources of air pollution
- Add new standards for maximum achievable control technology
- Deletion of one hazardous air pollutant

The Chair asked if anyone else wished to provide testimony.

No one appeared and the hearing was closed.

C. Sale of surplus property of industrial land located at 831 Westgate Blvd, Lincoln, Lancaster County, Nebraska, legally described as Westgate Park for Business and Industry, Block 5, Lot 3.

The Chair opened the public hearing and asked if anyone wished to provide testimony.

The oath was administered to Tom Kubert with Great Plains Appraisal, Inc...

Kubert stated Great Plains Appraisal contracted with the County for an appraisal of industrial land located at 831 Westgate Boulevard. Fair market value, as indicated by Kubert, was \$110,000 (\$2.75/square foot) on April 25, 2007. He stated there are sales in the area, however, the property is unique from the standpoint that there is a power line running through the middle of the parcel.

In response to a question asked by Workman, Kerry Eagan, Chief Administrative Officer, stated the purpose of the hearing was to take evidence regarding the fair market value of the parcel and evidence for and against whether the parcel should be declared surplus. He added that if the Board chooses to sell the parcel, a public sale must be held within 60 days from the date of the hearing.
