4) **PUBLIC HEARINGS**:

A. Continuation of a public hearing regarding County Street Name Change No. 07002, requested by the Director of Planning, to rename 'Woodlawn Road' as 'W. Humphrey Avenue' and to name the realignment of N.W. 40th Street and N.W. 48th Street. The Vice Chair reconvened the public hearing.

Ray Hill, Planning Department, appeared and reported he visited with some of the members of the Street Name Committee, Dennis Roth with Emergency Communications/911, and Dennis Bartels with Public Works, who indicated they prefer the name of West Old Woodlawn Road even though the total number of characters exceeds the recommended 14 characters. He added they would accept Old Woodlawn Road, however, they would prefer that 'west' be included to identify that the location is west of 1st Street.

The Vice Chair asked if anyone else wished to testify.

A real estate purchase agreement between Lancaster County and West O Properties L.L.C. for the purchase of 37.41 acres of real estate legally described as Lots 73 and 74 located in the Northwest Quarter of Section 29, Township 10 North, Range 6 East of the 6th P.M.. The cost to the County is \$2,250,750. (C-07-0311)

This item was held at the request of the County Attorney's Office.

- E. An agreement with the Child Guidance Center for the services of an internal case manager and for the provision of substance abuse evaluations for youth at the Youth Services Center. Term of the agreement is from July 1, 2007 to June 30, 2008. The County will pay \$63,614.84 for the services of the case manager and \$108,391.99 for substance abuse evaluations, for a total compensation amount of up to \$172,005.85. (C-07-00312)
- **MOTION:** Stevens moved and Hudkins seconded approval of an agreement with the Child Guidance Center for the services of an internal case manager and for the provision of substance abuse evaluations for youth at the Youth Services Center. Heier, Stevens and Hudkins voted aye. Motion carried.
 - F. An interlocal agreement between Lancaster County and the Administrative Office of the Courts, an agency of the State of Nebraska, for the administration of the Adult Drug Court for the District Court of Lancaster County through the provision of one Drug Court Coordinator, two Drug Treatment Court Caseworkers and one Clerk. Term of the agreement is July 1, 2007 through June 30, 2008. The Administrative Office of the Courts will pay the County \$172,039 for the services. (C-07-0313)
- **MOTION:** Stevens moved and Hudkins seconded approval of an interlocal agreement between Lancaster County and the Administrative Office of the Courts, an agency of the State of Nebraska, for the administration of the Adult Drug Court for the District Court of Lancaster County through the provision of one Drug Court Coordinator, two Drug Treatment Court Caseworkers and one Clerk. Stevens, Hudkins and Heier voted aye. Motion carried.
 - G. An agreement with Cedars Youth Services for tracker services for adolescents placed in the Lancaster County Juvenile Drug Court. Term of the agreement is July 1, 2007 through June 30, 2008. The County will pay up to \$28,000 for the services. (C-07-0314)
- **MOTION:** Hudkins moved and Stevens seconded approval of an agreement with Cedars Youth Services for tracker services for adolescents placed in the Lancaster County Juvenile Drug Court. Stevens, Heier and Hudkins voted aye. Motion carried.

- H. An agreement with Segal Advisors for pension consultation services for the Lancaster County Employees Pension Program. The agreement is effective upon execution by both parties and will continue for a period of one year. The agreement may be renewed for an additional one year period for Phases 3 and 4 upon mutual written agreement of the parties. The County will pay Segal Advisors as follows: Phase I, Initial Pension Plan Review: \$8,000; Phase 2, Review of Investment Plan: \$6,000; Phase 3, Assistance in Bidding: \$50,000 and Phase 4, As-Needed Investment Advice \$300 per hour. (C-07-0315)
- **MOTION:** Stevens moved and Hudkins seconded approval of an agreement with Segal Advisors for pension consultation services for the Lancaster County Employees Pension Program. Heier, Hudkins and Stevens voted aye. Motion carried.
 - I. Agreements with See The Trainer-Lincoln and Cardiology Group, L.L.C. d/b/a BryanLGH Heart Institute to provide specialized medical care and assistance to Lancaster County General Assistance clients who have pending claims with the Social Security Administration and may be eligible for retroactive Medicaid benefits. The agreements set forth a reimbursement arrangement in which the County will provide payment for the medical care and See The Trainer-Lincoln and Cardiology Group, L.L.C. d/b/a BryanLGH Heart Institute will reimburse the County if/when the General Assistance client is later determined eligible for Medicaid reimbursement. The agreements are effective upon execution of both parties and contains a 30 day termination provision. (C-07-0316 and C-07-0317)
- **MOTION:** Hudkins moved and Stevens seconded approval of agreements with See The Trainer-Lincoln and Cardiology Group, L.L.C. d/b/a BryanLGH Heart Institute to provide specialized medical care and assistance to Lancaster County General Assistance clients who have pending claims with the Social Security Administration and may be eligible for retroactive Medicaid benefits. Hudkins, Stevens and Heier voted aye. Motion carried.
 - J. A lease agreement between Lancaster County and Healthy Families Project for approximately 502.5 square feet of office space in Trabert Hall, located at 2202 South 11th Street, Lincoln, Nebraska. Term of the agreement is July 1, 2007 through June 30, 2008. Healthy Families Project will pay the County \$397.82 per month for the leased space. (C-07-0318)

- **MOTION:** Stevens moved and Hudkins seconded approval of a lease agreement between Lancaster County and Healthy Families Project for approximately 502.5 square feet of office space in Trabert Hall, located at 2202 South 11th Street, Lincoln, Nebraska. Hudkins, Stevens and Heier voted aye. Motion carried.

An agreement between the Lancaster County Engineering Department and Lincoln Electric System for Project No. HRRR-55(161), Walton, Nebraska to add roadway lighting at the intersection of South 120th and "A" Streets for safety purposes. The construction will occur in September/October of 2007 and the estimated cost to the County will be \$6,024. (C-07-0319)

Tom Fox, Deputy County Attorney, explained that the County Attorney's Office has concerns regarding the contracts (New Business Item 6M and 6N), and therefore, would not be signing off on them.

In response to questions asked by Hudkins, Fox stated the County Attorney's Office has concerns regarding warranties and indemnification which could be potential problems if litigation were to occur.
