The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:30 a.m..

1) <u>MINUTES:</u> Approval of the minutes of the Board of Commissioners meeting held on Tuesday, August 21, 2007.

MOTION: Stevens moved and Schorr seconded approval of the minutes of the

Board of Commissioners meeting held on August 21, 2007.

Heier asked for clarification on the motion relating to New Business Item 5H, specifically whether anything relating to architectural and design fees for the jail was included.

Stevens stated suggestions were made, however, no specific designations were included regarding how to use the one cent levy.

Schorr and Hudkins concurred.

ROLL CALL: Hudkins, Stevens, Schorr and Workman voted aye. Heier abstained from voting. Motion carried.

3) **SPECIAL PRESENTATIONS:**

A. Recommendation from the Visitors Promotion Committee in accordance with Neb. Rev. Stat. §81-1255 (Cum. Supp. 2006) to use ½% of the lodging tax paid to the Lancaster County Visitors Improvement raised between July 1, 2006 and June 30, 2007 to promote, encourage, and attract visitors to Lancaster County to use the County's travel and tourism facilities.

Appearing were Jeff Maul, Lincoln Convention and Visitors Bureau Executive Director, and Tom Lorenz, Chair of the Visitors and Promotion Committee.

Lorenz stated that it was determined by the Visitors Promotion Committee (VPC) that attractions are adequate in order to request the one-half percent lodging tax funds.

In response to a question asked by Workman, Maul stated the one-half percent for the previous six months would be approximately \$122,000 for a total of approximately \$250,000 for a one year period.

Maul introduced Norbert Greuner, with the Cornhusker Marriott Hotel, to the County Board.

C. Reappointment of John Chapo to the Lancaster County Visitors Promotion Committee to a four-year term, effective July 1, 2007 and terms expiring June 30, 2011 - Jeff Maul, Lincoln Convention and Visitors Bureau Executive Director; Scott Miller, VPC Chairman.

MOTION: Heier moved and Stevens seconded approval of the reappointment

of John Chapo to the Lancaster County Visitors Promotion Committee to a four-year term, effective July 1, 2007 and terms expiring June 30, 2011. Stevens, Heier, Schorr, Hudkins and

Workman voted aye. Motion carried.

4) **NEW BUSINESS:**

A. A resolution in the matter of final allocation of levy authority to all political subdivisions subject to County levy authority. (R-07-0080)

Dennis Meyer, Budget & Fiscal Officer, appeared and explained that the resolution sets the allocation for all miscellaneous subdivisions. He stated the Agricultural Society, Railroad Transportation Safety District (RTSD) and the Rural Library would receive the allocation which was requested in their budget document(s). In order for the fire districts to stay at the 15 cents, he said, the levy was maxed out at 9.9614 cents which would affect both the Malcolm and Raymond Rural Fire Districts. Both fire districts, Meyer said, would have to decrease their requests by \$4,000 to \$6,000.
