The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:30 a.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, September 11, 2007.

**MOTION:** Stevens moved and Hudkins seconded approval of the minutes of the Board of Commissioners meeting held on September 11, 2007. Hudkins, Stevens, Schorr and Heier voted aye. Motion carried.

2) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, September 18, 2007.

**MOTION:** Schorr moved and Hudkins seconded approval of all claims processed through September 18, 2007. Schorr, Hudkins, Heier and Stevens voted aye. Motion carried.

# 3) **OLD BUSINESS:**

A. A resolution instituting eminent domain proceedings against Douglas B. and Kimberly K. Rath, Trustees, Project C55-M-407(1), Tract No. 4 (Northwest 70<sup>th</sup> Street between West Adams and West Superior Streets). (R-07-0068)

# 3) **OLD BUSINESS CONTINUED:**

Tom Fox, Deputy County Attorney, explained that Jim Shotkoski, County Engineering Department, contacted the attorney for the Rath's and it appears an agreement can be reached. Recommendation from the County Attorney's Office was to hold the resolution for one week.

**MOTION:** Hudkins moved and Schorr seconded to hold Resolution 07-0068 instituting eminent domain proceedings against Douglas B. and Kimberly K. Rath, Trustees, Project C55-M-407(1), Tract No. 4 (Northwest 70<sup>th</sup> Street between West Adams and West Superior Streets) for one week.

Stevens stated the item has been delayed several times and he feels they should proceed with the resolution.

# 4) **NEW BUSINESS:**

A. A resolution in the matter of proclaiming Monday, September 24, 2007 as 'Family Day - A Day to Eat Dinner With Your Children'. (R-07-0088)

**MOTION:** Schorr moved and Stevens seconded approval of Resolution 07-0088 in the matter of proclaiming Monday, September 24, 2007 as 'Family Day - A Day to Eat Dinner With Your Children'.

The Clerk read the resolution into the record.

**ROLL CALL:** Schorr, Stevens, Hudkins and Heier voted aye. Motion carried.

B. An interlocal agreement with the City of Waverly for two Sheriff's Deputies for law enforcement services within the corporate limits of the City of Waverly. Term of the agreement is from October 1, 2007 to September 30, 2008. The County will be reimbursed up to \$164,560.90. (C-07-0364)

**MOTION:** Stevens moved and Hudkins seconded approval of an interlocal agreement with the City of Waverly for two Sheriff's Deputies for law enforcement services within the corporate limits of the City of Waverly. Stevens, Heier, Schorr and Hudkins voted aye. Motion carried.

C. A contract with Pavers, Inc., in the amount of \$373,711.06, for asphaltic concrete paving of Yankee Hill Road from South 40<sup>th</sup> Street east to South 56<sup>th</sup> Street; Project No. 08-04. The work will begin upon notice to proceed by the County and will be completed on or before November 9, 2007. (C-07-0365)

**MOTION:** Schorr moved and Stevens seconded approval of a contract with Pavers, Inc., in the amount of \$373,711.06, for asphaltic concrete paving of Yankee Hill Road from South 40<sup>th</sup> Street east to South 56<sup>th</sup> Street; Project No. 08-04. Heier, Schorr, Hudkins and Stevens voted aye. Motion carried.

D. An agreement with the Board of Regents of the University of Nebraska and the Lincoln Housing Authority for operation of the Nutrition Education Program in order to address the nutritional needs of certain limited income persons living in urban housing in Lancaster County. Term of the agreement is September 1, 2007 to August 31, 2008. The County will pay \$18,351 for the services which will be provided by the University. The Housing Authority will also pay \$10,519 for the services, combined with \$6,336 from the United States Department of Agriculture (USDA) Food Stamp Nutrition Education grant for a total of \$35,206. (C-07-0366)

**MOTION:** Stevens moved and Schorr seconded approval of an agreement with the Board of Regents of the University of Nebraska and the Lincoln Housing Authority for operation of the Nutrition Education Program in order to address the nutritional needs of certain limited income persons living in urban housing in Lancaster County. Schorr, Hudkins, Stevens and Heier voted aye. Motion carried.

E. A contract between Lancaster County and Bob Barker Company for the purchase of corrections staff clothing, inmate clothing and accessories on an as needed basis by the Lancaster County Corrections Department, Youth Service Center and the Community Mental Health Center. Term of the contract is one year from the date of execution of the contract, with an option to renew for two additional one year periods. The price of the clothing and accessories is according to the accepted proposal of the company which is attached to the contract. (C-07-0367)

Term of the contract is one year from the date of execution of the contract, with an option to renew for two additional one year periods. The price of the clothing and accessories is according to the accepted proposal of the company which is attached to the contract. (C-07-0369)

H. A contract between Lancaster County and Uniform Manufacturing, Inc. for the purchase of corrections staff clothing, inmate clothing and accessories on an as needed basis by the Lancaster County Corrections Department, Youth Service Center and the Community Mental Health Center. Term of the contract is one year from the date of execution of the contract, with an option to renew for two additional one year periods. The price of the clothing and accessories is according to the accepted proposal of the company which is attached to the contract. (C-07-0370)

**MOTION:** Schorr moved and Stevens seconded approval of a contract between Lancaster County and Uniform Manufacturing, Inc. for the purchase of corrections staff clothing, inmate clothing and accessories on an as needed basis by the Lancaster County Corrections Department, Youth Service Center and the Community Mental Health Center. Heier, Schorr, Stevens and Hudkins voted aye. Motion carried.

I. Acceptance of a grant award from the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance for the Comprehensive Approaches to Sex Offender Management: Improved and Enhanced Response to Sex Offenders in Lancaster County, Nebraska. The County will receive \$250,000. Term of the grant award is July 1, 2007 to June 30, 2009. (C-07-0371)

**MOTION:** Hudkins moved and Stevens seconded to accept a grant award from the United States Department of Justice, Office of Justice Programs, Bureau of Justice Assistance for the Comprehensive Approaches to Sex Offender Management: Improved and Enhanced Response to Sex Offenders in Lancaster County, Nebraska. Schorr, Stevens, Hudkins and Heier voted aye. Motion carried.

J. Change Order Numbers 1 and 2 to a contract between Lancaster County and Pyramid Roofing for roof replacement at Lancaster Manor. Change Order Number 1 is an increase of \$6,840 for installation of 28 dormers on the third story section of the building and for replacement of one by four inch wood. Change Order Number 2 is an increase of \$3,495 for the installation of 1,330 feet of ridge vent, rather than the previously contracted 780 feet of smart vent. The total increase of the contract price is \$10,335 resulting in a final contract price of \$134,328. (C-07-0372 and C-07-0373)

Bob Walla, Purchasing Department, explained that Change Order Number 1 is for installation of OSB sheeting on 28 dormers, not for replacement of the dormers.

**MOTION:** Hudkins moved and Stevens seconded approval of Change Order Numbers 1 and 2 to a contract between Lancaster County and Pyramid Roofing for roof replacement at Lancaster Manor. Stevens, Heier, Schorr and Hudkins voted aye. Motion carried.

K. An engineering agreement with Schemmer Associates Inc. for preliminary survey, roadway design and plan preparation for the regrading of Alvo Road from North 1<sup>st</sup> Street to North 14<sup>th</sup> Street. The work will be completed by January 4, 2008. The County will pay \$41,100 for the services. (C-07-0374)

**MOTION:** Hudkins moved approval of an engineering agreement with Schemmer Associates Inc. for preliminary survey, roadway design and plan preparation for the regrading of Alvo Road from North 1<sup>st</sup> Street to North 14<sup>th</sup> Street.

Motion died for lack of a second.

Stevens requested that the agreement be held for further information.

**MOTION:** Hudkins moved and Schorr seconded to defer the engineering agreement with Schemmer Associates Inc. and schedule for a Thursday Staff Meeting when Don Thomas, County Engineer, can be present. Heier, Schorr, Hudkins and Stevens voted aye. Motion carried.

L. An amendment to an agreement with PharMerica under County Contract No. C-01-568 for pharmacy and related services at the Lancaster County Corrections Department. The original agreement will be amended to extend the term to November 15, 2007. (C-07-0381)

This item was held.

M. Recommendation from the Purchasing Agent and representatives of the Lancaster County Corrections Department, Youth Services Center, Community Mental Health Center, Lancaster Manor and the Health Department to award a bid for medical equipment and supplies to Moore Medical and Midland Medical. All County and City agencies will order from the contract on an as needed basis. Prices are outlined in the proposal and will remain firm for the term of the contract. (B-07-0056)

**MOTION:** Stevens moved and Schorr seconded approval to award a bid for medical equipment and supplies to Moore Medical and Midland Medical for all County and City agencies. Hudkins, Stevens, Schorr and Heier voted aye. Motion carried.

N. Transportation Enhancement Program Notification of Project Completion and Materials Certification for the Jamaica North Trail -Phase I, Project No. ST PB-55(150) Control No. 12735.

He explained that the poles are located on a road which has never been vacated, however, it was abandoned approximately ten to 15 years ago.

Heier declared a conflict of interest and requested Commissioner Hudkins to Chair the meeting.

# 6) OTHER BUSINESS CONTINUED:

Schroeder explained he visited with Commissioner Hudkins last week who indicated that Lancaster County owns part of the road. He further stated that the road was maintained by Otoe County who made the decision to abandon the road, but never close it. Schroeder said he told OPPD the road was never closed, however, they have proceeded to erect three poles in the center of the road.

Schroeder asked if OPPD could erect poles on a road which was never vacated and if either Lancaster or Otoe counties could be liable.

Board consensus to direct Kerry Eagan, Chief Administrative Officer, to request a legal opinion regarding ownership of South 190<sup>th</sup> Street on the Otoe/Lancaster County line.

Heier resumed as Vice Chair of the meeting.
