The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 9:30 a.m..

1) MINUTES: Approval of the minutes of the Board of Commissioners meeting held on Tuesday, September 18, 2007.

**MOTION:** Stevens moved and Heier seconded approval of the minutes of the Board of Commissioners meeting held on September 18, 2007. Stevens, Schorr, Heier and Workman voted aye. Hudkins was absent from voting. Motion carried.

2) <u>CLAIMS:</u> Approval of all claims processed through Tuesday, September 25, 2007.

**MOTION:** Heier moved and Stevens seconded approval of all claims processed through September 25, 2007. Schorr, Heier, Stevens and Workman voted ave. Hudkins was absent from voting. Motion carried.

(Hudkins entered the Hearing Room.)

# 3) **PUBLIC HEARINGS:**

A. County Special Permit No. 07033, requested by Greg Sanford, to allow mining and extraction of soil on approximately 159.39 acres, more or less, generally located on the east side of North 56<sup>th</sup> Street/Highway 77, between Branched Oak and Davey Roads, Lancaster County, Nebraska. (See New Business Item 5A for correlating resolution.)

The Chair opened the public hearing and asked if anyone wished to appear in favor of the proposal.

The oath was administered to Mark Hunzeker, attorney appearing on behalf of Greg Sanford, applicant.

Hunzeker gave a brief overview stating that the proposal is almost identical to a previous proposal which was before the County Board approximately one year ago. He stated it maintains the drainage in the same direction and will be regulated by State and Federal authorities. The Planning Commission, he said, proposed the following conditions to which they object: 1) Restriction of the hours of operation from 9 a.m. to 4 p.m. Monday through Friday; 2) \$5,000 performance bond and 3) Access to site shall be limited to Highway 77.

The following individuals were administered the oath and provided testimony in opposition to the proposal addressing concerns relating to safety, enforcement and oversight of conditions placed upon the special permit, access to the proposed site, hours of operation, warning signs for entering and exiting trucks, removal of dirt/spills upon the road and, collection of sales tax as well as property tax which is no longer has greenbelt status. It was also suggested that a moratorium be declared on soil mining to allow a task force to be created to discuss such issues as oversight/enforcement of conditions placed on such proposals, development of regulations, inspection fees, development of stringent re-seeding and vegetative quidelines.

The oath was administered to Mike DeKalb, Planning Department.

In response to question asked by Schorr, DeKalb stated no soil mining permits have been rejected. Also discussed were types of restrictions/conditions placed upon special permits to avoid future construction of motor sports facilities, slick road conditions, performance bonds, inspection and permit fees and collection/payment of property tax.

The oath was administered to Norm Agena, County Assessor/Register of Deeds.

In response to a question regarding soil mining properties having greenbelt status, Agena explained when his office is aware that soil mining is taking place they recapture the value on the portion being mined.

Stevens asked if there was a way to obtain a survey map indicating an applicant is in compliance of conditions at the end of a soil mining project.

DeKalb explained the drawings, which would be a part of the applicant's file, show existing and proposed final contours. He suggested that once a project is completed there be certification by an engineer indicating that it is 'finished as shown'.

Discussion took place regarding the process for revocation/review of the special permit. DeKalb explained the process and added that the Board could request the applicant to appear at a County Board meeting upon renewal of a permit.

Stevens asked what options the County Board would have if it were brought to their attention by Building and Safety that an applicant was not complying with the conditions of a special permit.

# 3) **PUBLIC HEARINGS CONTINUED:**

DeKalb stated he thought the Board could request the permit be brought back to them for a hearing to inquire whether the applicant was in compliance with the conditions. If it is found that the applicant is not in compliance, the permit could be repealed by the Board or it could be sent back to Building and Safety to follow their provisions of enforcement.

Heier submitted an email from Jeff Atkinson in support of the special permit (Exhibit 6) and an email from Shannon McGovern also supporting the special permit (Exhibit 7).

In closing, Hunzeker stated the property would not be managed by Mr. Sanford. He explained Sanford will be entering into an agreement with a contractor and that it will be supervised by engineer hired by Sanford. The contractor will be responsible for all of the conditions of approval for the special permit and any National Pollutant Discharge Elimination System (NPDES) permit issued. Hunzeker added that the agreement will include inspection by the engineer to ensure compliance and determination of how much soil is being removed.

Discussion took place regarding hours of operation.

The Chair asked if anyone else wished to provide testimony.

No one appeared and the hearing was closed.

Extensive discussion took place regarding limiting operation to weekdays (Monday through Friday) and hours of operation including limiting access onto Highway 77 during specific hours.

**FRIENDLY AMENDMENT:** Stevens moved that the hours of operation be limited to one-half hour after sunrise to one-half hour before sunset, excluding 7:30 a.m. to 8:30 a.m. and 4:30 p.m. to 5:30 p.m..

Heier accepted the friendly amendment, however, the seconder did not concur.

Heier withdrew his original motion.
