The agreement sets forth a reimbursement arrangement in which the County will provide payment for the medical care and Star Anesthesia will reimburse the County if/when the General Assistance client is later determined eligible for Medicaid reimbursement. The agreement is effective upon execution of both parties and contains a 30-day termination provision. (C-08-0067)
