The location announcement of the Nebraska Open Meetings Act was given and the meeting was called to order at 10:05 a.m..

1) MINUTES: Approval of the minutes of the Board of Equalization meeting held on Tuesday, November 4, 2008.

MOTION: Stevens moved and Schorr seconded approval of the minutes of the

Stevens, Schorr and Workman voted aye. Motion carried.

#### 2) ADDITIONS AND DEDUCTIONS:

Approval of 6 additions and deductions to the tax assessment rolls per Attachments "A" and "B".

MOTION: Stevens moved and Schorr seconded approval of the additions and

deductions to the tax assessment rolls per Attachments "A" and "B". Schorr, Hudkins, Stevens and Workman voted aye. Motion carried.

MOTION: Stevens moved and Hudkins seconded approval of motor vehicle tax exemptions for Alzheimer's Association-Great Plains, Cedars Youth Services, Christian Retirement Homes, Inc. d/b/a Eastmont Towers, Community Blood Bank, Cristo Rey Catholic Church, Immaculate Heart of Mary Church and Shepherd of the Hills Lutheran Church. Schorr, Stevens, Hudkins and Workman voted aye. Motion carried.

#### 4) 2008 451 TAX EXEMPTION APPLICATION ON REAL PROPERTY:

#### **Victory Fellowship Church of Lincoln**

Scott Gaines, Deputy County Assessor/Register of Deeds, recommended approval and stated the Parcel Identification No. in the notice mailed to the Church was incorrect. He stated it should be 16-10-200-018-000.

MOTION: Hudkins moved and Stevens seconded to accept the recommendation of the Deputy County Assessor/Register of Deeds to approve the 2008 451 tax exemption application on real property for Victory Fellowship Church of Lincoln. Stevens, Schorr, Hudkins and Workman voted aye. Motion carried.

## 5) NOTICE OF ASSESSED VALUATION CHANGE FOR PROPERTY TAXATION PURPOSES:

#### **Everett and Kay Larson**

Gaines gave a brief overview of the notice and explained there was an error in the square footage of the basement.

**MOTION:** Schorr moved and Hudkins seconded to send notice of assessed valuation change for property taxation purposes to Everett and Kay Larson. Stevens, Schorr, Hudkins and Workman voted aye. Motion carried.

#### 6) NOTICE OF PROPOSED CHANGE IN EXEMPTION STATUS FOR 2008:

#### **Nebraska School Activities Association**

Jim Tenopir, Executive Director of the Nebraska School Activities Association, stated the building was vacated during the latter part of March, 2008. He explained they continue ownership of the property, however, it is for sale. Tenopir stated they are not using the building for the purpose of administering high school activities, but that they do have some belongings located in the facility. He said they aren't opposed to putting the building on the tax rolls, however, it was used for a portion of the year for educational purposes. Tenopir added that the taxable value is a value that is in excess of their sale price.

In response to a question asked by Hudkins, Tenopir stated they do have some furniture, shelving and cabinets stored in the building. He added they did remove their final records during June and July.

Gaines stated there is a five part test to maintain exemption status and it is their belief that there is a question regarding the educational purpose. He explained the Assessor's Office feels that the building is a vacant, commercial building for sale rather than property that is currently being used exclusively for educational purposes. Gaines added that it appears the educational purpose of the association has moved to the new building.

Schorr asked Tenopir what price they currently have the building listed for and if anyone has expressed interest.

Tenopir stated they listed it for \$550,000 and offered it to an interested party for \$450,000 within the last 30 to 45 days.

Gaines stated the current assessed value of \$492,500 is not firm. He explained it can be appealed and that the Assessor's Office would work to place an appropriate value on the property under the current climate.

Stevens asked if there was a specific point during a year when a tax exemption can change.

Gaines stated the statutes indicate that at any time during the year, the Board of Equalization or the County Assessor may cause a hearing to be held to review if an exemption is still warranted as of that point in time.

Discussion also took place regarding proration with Schorr asking if the Board is prohibited by statute to prorate. Fox stated there is nothing specific in the statute to prohibit proration, however, the general view is that if something isn't specifically stated or outlined you don't 'read between the lines'.

Gaines reiterated that the Assessor's Office would review the valuation to determine an appropriate value.

In response to a comment made by Schorr, Tenopir stated they used the facility for the first quarter exclusively for educational purposes.

**MOTION:** Hudkins moved and Schorr seconded retention of tax exemption status for 2008 for the Nebraska School Activities Association (Parcel I.D. No. 17-27-217-005-000).

Stevens indicated he would not support the motion stating that he feels the property is not used exclusively for educational purposes. He said he agrees with the recommendation from the County Assessor/Register of Deeds Office that the exemption should be removed.

Fox referred to the statute regarding proration stating that it reads as follows, "If an exemption is denied the county board of equalization shall place on the property tax rolls retroactive to January 1 of that year if on the date of the decision the county board of equalization determines that the property qualifies."

**ROLL CALL:** Schorr, Hudkins and Workman voted aye. Stevens voted no. Motion carried.
